(U) A bizarre twist to the Dakota Access Pipeline protest underway in Morton County, North Dakota. YouTube videos posted online by “anonymous Agents” have issued threats against President Obama, North Dakota’s Governor, National Guard soldiers, law enforcement officers, and both executives and construction workers involved in the pipeline. The videos were first seen last week.

**(U) United States Anti-Doping chief condemns cyber-attack as cowardly & despicable’**

(U) United States Anti-Doping chief Travis T Tygart has condemned as "cowardly and despicable" a cyber-attack in which the personal details of high-profile Olympic athletes were illegally accessed.

Hackers claim to have obtained information relating to the likes of American tennis stars Serena and Venus Williams and four-time 2016 gymnastics gold medalist Simone Biles.

**(U) Hillary Clinton: U.S. will treat cyberattacks ‘just like any other attack’**

(U) Democratic presidential nominee Hillary Clinton on Wednesday said as commander in chief the U.S. will deploy its military to respond to cyberattacks waged against its interests.

Amid a wide-ranging hacking campaign that has successfully claimed several victims from the Democratic Party in recent months, Mrs. Clinton indicated her administration will pursue offensive military campaigns against foreign hackers should she wins November’s general election.

INTERNATIONAL**(U) Cry ransomware uses Google Maps to find victim locations**

(U) BleepingComputer researchers discovered a new piece of ransomware, dubbed Cry or CSTO, as it pretends to come from a fake group called the Central Security Treatment Organization, was using public Websites to host information about victims, and could determine a victim’s location by using a nearby wireless service set identifier (SSID) to query the Google Maps application programming interface (API). Researchers also spotted the malware encrypting the victim’s files and deleting Shadow Volume Copies to prevent users from restoring their files.

**(U) Attackers combine three botnets to launch massive DDoS attack**

(U) Sucuri researchers reported attackers combined a home router botnet comprised of 11,767 devices, an internet of things (IoT) closed circuit television (CCTV) botnet comprised of 25,000 cameras, and a botnet made up of compromised Linux servers to carry out a Layer 7 distributed denial-of-service (DDoS) attack involving traffic from over 47,000 Internet Protocol (IP) addresses. Sucuri stated the 3botnet distribution enabled the attacker to send 120,000 requests per second without disrupting the operation of the infected machines.

**(U) Krebs' site under attack after alleged owners of DDoS-for-hire service were arrested**

(U) After security journalist Brian Krebs exposed the DDoS-for-hire service, vDOS, and the alleged owners of the service were arrested, a massive attack was launched against the Krebs on Security site.

**(U) New Linux Trojan discovered coded in Mozilla's Rust language**

(U) Dr. Web security researchers discovered a new Trojan coded in Mozilla's Rust programming language was targeting Linux-based platforms and found that an attacker in control of an Internet Relay Chat (IRC) channel can send a message to the channel's public chat that forces all connected bots to parse the message and execute the malicious action. The researchers believe this is a testing version of the malware as the Trojan infects victims and gathers information about the device's local system and sends it to its command and control (C&C) center.

**(U) Free decrypter available for Philadelphia ransomware**

(U) An Emsisoft security researcher released a decrypter for the Philadelphia ransomware that can unlock a victim's files for free after the researcher discovered the malware was deleting a predetermined number of files from an infected device if the user did not immediately pay the ransom.

**(U) Critical MySQL zero-day exposes servers to attacks**

(U) An independent security researcher discovered a critical zero-day vulnerability affecting the MySQL open-source database software that can be exploited by an attacker who can authenticate to the MySQL database via a Web interface or network connection to leverage arbitrary code execution with root privileges, which can compromise the server running MySQL. The researcher reported that all MySQL branches are susceptible to the attack, and that the attack can be leveraged on a device with Linux security modules installed.

**(U) Siemens fixes several flaws in SIPROTEC products**

(U) Siemens released firmware updates addressing vulnerabilities in its SIPROTEC 4 and SIPROTEC Compact devices after Kaspersky Lab researchers found the devices were plagued with a flaw that an attacker with network access could exploit to bypass authentication mechanisms and carry out administrative operations, and a flaw that could allow an attacker with network access to perform those actions while a legitimate user is logged in to the Web interface. Siemens advised customers to use network segmentation, virtual private networks (VPNs), and firewalls to protect their systems against attacks.

A short time ago, I (along with other agency heads) was briefed about this afternoon's demonstration that is being allowed on the lower part of the mall. Based on the briefing, I can assure you that there is a security plan in place with adequate resources and personnel to protect the capitol and those in it. That is, in the event any of the participants in the rally attempt to rush the capitol or damage any of the property. If that should happen, the capitol will be locked down and you will receive further instructions.**

### **DALRYMPLE PRESSES WHITE HOUSE, FEDERAL AGENICES TO SUPPORT PUBLIC SAFETY EFFORTS**

BISMARCK, N.D. – Gov. Jack Dalrymple today called on the White House and federal agencies to provide federal assistance in maintaining peace and public safety for the duration of protest activities involving the Dakota Access Pipeline.

“The federal government’s announcement on Friday regarding the Dakota Access Pipeline has extended indefinitely the period of time necessary to bring the issue to a resolution,” Gov. Dalrymple said. “With a decision on the pipeline delayed indefinitely, the federal government shares in the responsibility of ensuring that peace and order are maintained.”

Dalrymple spoke today with White House officials and has also been in contact with the U.S. Army Corps of Engineers, the Department of Interior and the Department of Justice to press for federal assistance, both personnel and financial support. Dalrymple called for federal officials to provide assistance for as long as resources are needed to maintain public safety.

“I’m going to hold the federal government to its word, when the Corps and the departments of Interior and Justice delayed a decision on the pipeline’s construction, and offered to deploy resources to North Dakota to help “defuse tensions, support peaceful protest, and maintain public safety,” Dalrymple said.

Dalrymple said he has also spoken with the state’s Congressional Delegation, requesting their assistance in securing federal support. That support is needed in the form of financial assistance and in law enforcement personnel.

To date, the state Highway Patrol has incurred more than \$700,000 in expenses associated with pipeline protest activities. Morton County officials have reported incurring costs of about \$100,000 a week for a total of approximately \$400,000.

Morton County Sheriff’s deputies and state troopers today reported arresting 22 people at a pipeline construction site near Glen Ullin. Additionally, the North Dakota Department of Transportation and Highway Patrol today again closed ND Highway 1806 to southbound traffic about six miles south of Mandan. 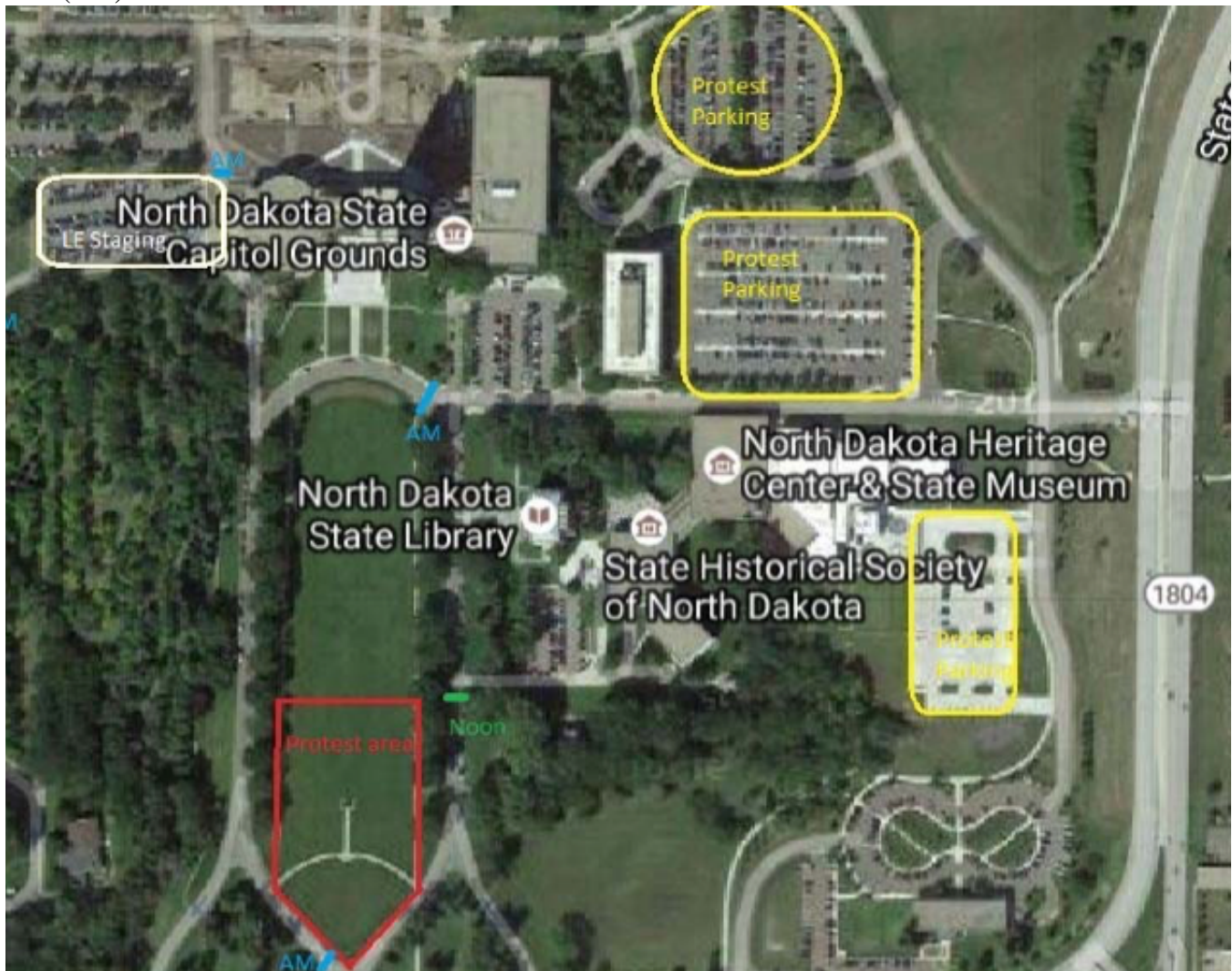

Good Morning Alphonso,

We have a unique situation and I would like to float something your way for ideas. We have been going for over a month now with the DAPL protests and the resources are being stretched pretty thin. A few months back, the NDHP did some policy revisions to keep our exempt staff from being overworked/undercompensated in situations out of the ordinary such as flooding and extended protests like we are dealing with now. Once our exempt staff exceed 171 hours in a 28 day period, we begin to compensate them at straight pay, hour for hour over 171. Keep in mind that our sworn staff are subject to different rules under FLSA for law enforcement/fire and are on 28 day periods vs a 40 hr work week. Normal months they manage their time within the 28 days and rarely exceed 171 and are basically not being compensated under 171.

Due to the extreme amount of time and short notice required to respond, we are working our staff long hours and are paying call time for those required to respond within 15 minutes. There are exempt personnel who are also part of that group that need short notice response and have well exceeded 171 hours. As part of the emergency funding, we have visited with DES and they have approved the call pay as part of this DAPL protest. We will be paying our sworn staff on that 15 minute time frame 2.00/hr call time. Do you have any recommendations on whether we pay our exempt staff the same 2.00/hr call time if they are being held to the short response time?

On another note, we have asked for funding next session to address call time as a whole. We do not set a time limit to respond, but we do ask our troopers on call to be on call and respond as reasonable. That seems to be getting harder to manage as years pass and we would like to begin to compensate for call, but also tie more specific restrictions to it.

I am away from my office dealing with protest stuff, but you can reach me on my cell at 701-426-2536. Not to be pushy, but time is of the essence if you are able to provide any guidance.
