





Regarding the air asset mission request via EMAC, I've attached two REQ-A Section 2 files:

EMAC Offer NEMA 1060 2F excel.pdf – for the fixed-wing aircraft offer EMAC Offer NEMA 1060 2R excel.pdf – for the rotory wing aircraft offer.

The only differences between the two aircraft are directly related to the cost of operations for both aircraft. This is based on the understanding from the EMAC request, that our air assets would be working in North Dakota for seven straight days, back to Nebraska for seven days, and then working in North Dakota seven more straight days—thus, four travel days (and associated costs) were built in per person and vehicle/aircraft.

The fixed wing aircraft is a Cessna T206. FEMA does not have a cost code for this, but they do have a cost code (#8906) for a Navajo PA31 fixed wing aircraft, which is rated at the same power (310 horsepower), so for planning purposes, I have used that cost code of \$568/hour. Note that, per FEMA guidance, this equipment rate does include maintenance, fuel, repairs, etc., but does not include operator cost.

The rotary wing aircraft is a Bell model 407 helicopter. This particular model does have a FEMA cost code (#8905), so we have used the FEMA equipment rate of \$755/hour for this asset. As with the fixed wing, the equipment rate includes maintenance, fuel, repairs, etc., but does not include operator cost.

Going through the sections of Section II...

Travel Costs: As with the other EMAC mission, we are operating under the understanding that our personnel will be provided lodging, and lunch & dinner meals by the state of North Dakota. Thus, we have assumed breakfast (20% of \$51/day per diem: \$10.20) for 14 days, and then full meal per diem for a total of four travel days for four persons. Lodging costs (at a per diem rate of \$91/day) were included for each of the four personnel for a total of four travel days. The "Total Government Vehicle Expenses" was based on one ground vehicle traveling 680 miles one-way at a rate of \$0.54/mile on four travel days. The "Total Air Travel Expenses" is based on the FEMA equipment rate for the Nebraska State Patrol multiplied by the estimated flight time from Nebraska to North Dakota (3 hours for the fixed wing, 3.5 hours for the helicopter) for four travel days.

Equipment Costs: The only entry here is the aircraft being used.

our State Patrol has been communicating with North Dakota Highway Patrol. They have suggested that he should plan on flying up to 10 hours/day. Thus, we have used that figure and multiplied it by cost per hour for the appropriate FEMA cost code.

Commodity Costs: We have no known commodities to document here.

Other Costs: We have included a hangar rental cost in North Dakota of \$25/day for 13 days.

Personnel Costs: As with our other EMAC mission to North Dakota, we have found that the easiest way to accurately capture personnel costs per individual is to use two lines for each person. This provides the most efficient mechanism to reflect days that are pure overtime, for those individuals who are not overtime-exempt.

Regarding the air asset mission request via EMAC, I've attached two REQ-A Section 2 files: EMAC Offer NEMA 1060 2F excel.pdf – for the fixed-wing aircraft offer EMAC Offer NEMA 1060 2R excel.pdf – for the rotory wing aircraft offer. The only differences between the two aircraft are directly related to the cost of operations for both aircraft. This is based on the understanding from the EMAC request, that our air assets would be working in North Dakota for seven straight days, back to Nebraska for seven days, and then working in North Dakota seven more straight days—thus, four travel days (and associated costs) were built in per person and vehicle/aircraft.

The fixed wing aircraft is a Cessna T206. FEMA does not have a cost code for this, but they do have a cost code (#8906) for a Navajo PA31 fixed wing aircraft, which is rated at the same power (310 horsepower), so for planning purposes, I have used that cost code of \$568/hour. Note that, per FEMA guidance, this equipment rate does include maintenance, fuel, repairs, etc., but does not include operator cost.

The rotary wing aircraft is a Bell model 407 helicopter. This particular model does have a FEMA cost code (#8905), so we have used the FEMA equipment rate of \$755/hour for this asset. As with the fixed wing, the equipment rate includes maintenance, fuel, repairs, etc., but does not include operator cost.

Going through the sections of Section II...

Travel Costs: As with the other EMAC mission, we are operating under the understanding that our personnel will be provided lodging, and lunch & dinner meals by the state of North Dakota. Thus, we have assumed breakfast (20% of \$51/day per diem: \$10.20) for 14 days, and then full meal per diem for a total of four travel days for four persons. Lodging costs (at a per diem rate of \$91/day) were included for each of the four personnel for a total of four travel days. The "Total Government Vehicle Expenses" was based on one ground vehicle traveling 680 miles one-way at a rate of \$0.54/mile on four travel days. The "Total Air Travel Expenses" is based on the FEMA equipment rate for the Nebraska State Patrol multiplied by the estimated flight time from Nebraska to North Dakota (3 hours for the fixed wing, 3.5 hours for the helicopter) for four travel days.

Equipment Costs: The only entry here is the aircraft being used. ur State Patrol has been communicating with North Dakota Highway Patrol. They have suggested that he should plan on flying up to 10 hours/day. Thus, we have used that figure and multiplied it by cost per hour for the appropriate FEMA cost code.

Commodity Costs: We have no known commodities to document here.

Other Costs: We have included a hangar rental cost in North Dakota of \$25/day for 13 days.

Personnel Costs: As with our other EMAC mission to North Dakota, we have found that the easiest way to accurately capture personnel costs per individual is to use two lines for each person. This provides the most efficient mechanism to reflect days that are pure overtime, for those individuals who are not overtime-exempt.
