Subject: Update on Weekend Activities

Commissioners, Cty. Mgr. Kleinschmidt, and Dep. Mgr. Williams,

I wanted to update you on what has been occurring this weekend with regard to the protests that have been occurring from a County perspective.

Saturday 07-09-2016:

- At 6 AM Saturday we began covering police service for Falcon Heights and Lauderdale. This will continue until at least Tuesday July 12th.
- Very quiet for County activity over the weekend until 6 pm on Saturday (last night) when protesters moved from the Mansion towards the freeway. Near dusk, the protesters blocked the freeway.
- Sheriff's Office was asked at about 9 PM to activate our Mobile Field Force which was then paged out and was deployed in a backup role. We were not on the freeway during the incident. No deputies were injured.
- Two waves of prisoners taken into custody were brought to the LEC Jail. 50 were booked into custody for Gross Misdemeanor Riot for freeway activity. They are still in-custody. The later wave of about 60 were ticketed and released for misdemeanor charges related to Grand Ave. march.
- We overstaffed the jail to accommodate these arrests and all went very well.
- Our Mobile Field Force left the field at about 4:30 AM today (Sunday).

Sunday 07-10-2016:

- Today our Mobile Field Force came back to work at 11 AM. We are now supporting operations for the for the St. Anthony protest scheduled for this afternoon. We are working with Hennepin County, Roseville, and New Brighton. Very well organized with a good operational plan. We also have deputies doing other security operations to cover key locations.
- The St. Anthony protest is supposed to take place at the St. Anthony City Hall. [REDACTED]

Subject: Update Protests as of 0300hrs

This is brief synopsis from the newsworthy events from tonight, most of the demonstrations were peaceful except the ones noted below. An Excellent job was done by SPPD Incident Commander Steve Frazier and the detail units along with the MFF folks!!

Fran I created a folder on the shared desktop with info and snapshots from social media.

Commenced at 0120hrs: Oxford/Summit (corner intersection by Governor's Mansion)

Group of 40 people (15-20 Unruly) Police disengaged from area and were forced to leave squad car behind as a result one squad was damaged with windows being busted out. The unruly group began throwing rocks at police. One protester had a bat. Most of the destruction was also observed via live stream. MFF was able to safely get the vehicle out of the area. A small group also lit an American Flag on fire outside the Governor's mansion. (as of 0300hrs protesters still in area, but controlled and MFF standing down)



Commenced at 0004hrs- Protesters were also involved in CDTF at Carty Park 705 Iglehart Ave, mobile trailer cams were reportedly damaged

Commenced at 0100hrs -Demonstrators of approx. 40-50 at Snelling/University were mainly peaceful and quiet (as of 0300hrs only a handful protesters still sitting in middle of intersection)

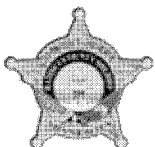

Forced overtime: none

Mass arrests were made during civil unrest on I-94 in St. Paul. Approximately 45 people were arrested for GM-Riot and transported via Metro Transit bus to the ADC around 2215. The facility was locked down and all afternoon staff members were required to remain in the facility on overtime to assist. The detainees were all cooperative with the booking process. Once booked and processed, all were moved to various areas in the facility. Due to overcrowding with females in 1B, several inmates are sleeping on cots on the floor in 1B and court holding room.

At approximately 0350, another large group of detainees arrived via two Metro Transit buses. This group was arrested in the area of Grand and Dale in St. Paul for M-Unlawful Assembly and Public Nuisance. SPPD determined that all who could be positively identified would be cited and released from the ADC garage. Of approximately 50, all but 17 were cited and released from the garage and escorted to University and Olive

streets. 17 were taken into the ADC to be booked and processed for the misdemeanor charges.

Outstanding teamwork and professionalism by the entire afternoon and overnight shifts as well as additional supervisors and others who came in to assist! Several afternoon shift staff members worked 12-16 hour shifts and kept a great attitude throughout!

During this process inmate [REDACTED] arrived via SPPD, was uncooperative in the booking area, and was escorted to holding room 3 and handcuffs were changed out. Handcuffs were later removed. Later in the night while the second group of protesters were arriving, he began to flood his cell, removed his clothes, and caused a disturbance. He was placed in handcuffs and leg restraints and moved to holding room 1. He had to be threatened with the taser to get compliance. Reports and seg log written.



Dear Sergeants and Staff,

Thank you for the positive and professional work each of you deliver to the public living and working in Ramsey County. The tragedies in St. Anthony and Dallas give us all pause. I know all of you will continue to deliver the best service possible. In the next days, weeks and months, all of us will be inundated with media coverage of these events. It is important to regulate your exposure and keep perspective on the events. Please make sure you are getting plenty of rest and incorporating recreational and psychical activities into your day.

I toured the detention center today and stopped into every pods. I visited with the inmates to give perspective on our operations. I let them ask questions and vent.

In the coming days, there will be protests regarding these events. The public has the right to assemble and have their voices heard. For the most part, the protests in the area have been peaceful. We will have security outside of the LEC every shift change through next week. There is a planned protest at SPPD HQ for Sunday, at 2pm. Please check your email for transportation updates. I would recommend staff to avoid Grove Street on Sunday afternoon. We don't have a clear number of how many will assemble for the protest. In any case, Cmdr. Loots (651-248-2500) will have security operations for the event. Cmdr. Salter (651-248-2419) will be working closely with Cmdr. Loots on the detail. Lt. Lindberg will be on call this weekend and he will be monitoring events.

I would like the operations in the detention center stay as close to normal as possible. As always, I encourage the sergeants to make decisions based on the safety of staff, inmates and visitors.

Several dozen supporters of those arrested during the I-94 riot gathered in the south parking lot and public lobby area. There were about 20 people inside the public lobby complete with food, coffee, and live-streaming cameras to capture the release of the inmates they bailed out. Although the area was congested, they were all respectful and cooperative. Once all were released, they cleaned up the area

inside and out and left the LEC. The south lobby door was secured after that to avoid further issues. Those with business in the ADC were allowed in. Excellent job by afternoon and midnight shift lobby staff who fielded dozens of phone calls and dealt with the dozens of bails/bonds. Officers Preiner, Lydon, Sirian, Erickson, Brett Borowske, and Regner all assisted in lobby. Transfer release staff including Downing, Gratz, Shaffer, and Lehman also assisted with the movement of the inmates out of the facility.

Due to the large number gathered at the ADC as well as potential events occurring near the Governor's Residence, Commander Maher ordered all afternoon shift staff to remain on site to assist with possible mass bookings. As Commander Maher provided intelligence from SPPD EOC, staff were gradually excused. All afternoon staff left the building by 0300 or sooner. Great teamwork and patience by all involved.

We continued to monitor social media and live streams as Summit Avenue was cleared by SPPD. Several midnight shift staff members volunteered to remain on standby to hold over if needed. No bookings related to those events have been made.

Washington County dropped off inmate [REDACTED] who could not be housed in their facility due to numerous medical issues related to jumping from a third story window prior to arrest. He had a Ramsey County warrant for felony auto theft. Our medical staff also determined that we could not care for him in the ADC. The on-call judge was contacted and allowed the inmate to be OR'ed with a future court date.. He was released and a taxi eventually took him home.

24 Restore was called after a juvenile female intentionally defecated on the floor of a holding cell in prebook. She was sent to the JDC unprocessed.

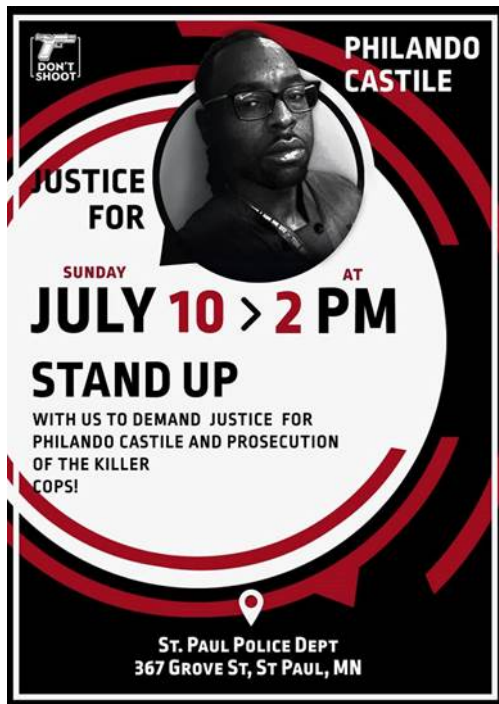

Dear Sergeants and Staff,

Thank you for the positive and professional work each of you deliver to the public living and working in Ramsey County. The tragedies in St. Anthony and Dallas give us all pause. I know all of you will continue to deliver the best service possible. In the next days, weeks and months, all of us will be inundated with media coverage of these events. It is important to regulate your exposure and keep perspective on the events. Please make sure you are getting plenty of rest and incorporating recreational and psychical activities into your day.

I toured the detention center today and stopped into every pods. I visited with the inmates to give perspective on our operations. I let them ask questions and vent.

In the coming days, there will be protests regarding these events. The public has the right to assemble and have their voices heard. For the most part, the protests in the area have been peaceful. We will have security outside of the LEC every shift change through next week. There is a planned protest at SPPD HQ for Sunday, at 2pm. Please check your email for transportation updates. I would recommend staff to avoid Grove Street on Sunday afternoon. We don't have a clear number of how many will assemble for the protest. In any case, Cmdr. Loots (651-248-2500) will have security operations for the event. Cmdr. Salter (651-248-2419) will be working closely with Cmdr. Loots on the detail. Lt. Lindberg will be on call this weekend and he will be monitoring events.

I would like the operations in the detention center stay as close to normal as possible. As always, I encourage the sergeants to make decisions based on the safety of staff, inmates and visitors.

Commissioners, Cty. Mgr. Kleinschmidt, and Dep. Mgr. Williams,

I wanted to update you on what has been occurring this weekend with regard to the protests that have been occurring from a County perspective.

Saturday 07-09-2016:

- At 6 AM Saturday we began covering police service for Falcon Heights and Lauderdale. This will continue until at least Tuesday July 12th.
- Very quiet for County activity over the weekend until 6 pm on Saturday (last night) when protesters moved from the Mansion towards the freeway. Near dusk, the protesters blocked the freeway.
- Sheriff's Office was asked at about 9 PM to activate our Mobile Field Force which was then paged out and was deployed in a backup role. We were not on the freeway during the incident. No deputies were injured.
- Two waves of prisoners taken into custody were brought to the LEC Jail. 50 were booked into custody for Gross Misdemeanor Riot for freeway activity. They are still in-custody. The later wave of about 60 were ticketed and released for misdemeanor charges related to Grand Ave. march.
- We overstaffed the jail to accommodate these arrests and all went very well.
- Our Mobile Field Force left the field at about 4:30 AM today (Sunday).

Sunday 07-10-2016:

-Today our Mobile Field Force came back to work at 11 AM. We are now supporting operations for the for the St. Anthony protest scheduled for this afternoon. We are working with Hennepin County, Roseville, and New Brighton. Very well organized with a good operational plan. We also have deputies doing other security operations to cover key locations.

-The St. Anthony protest is supposed to take place at the St. Anthony City Hall. [REDACTED]
