Colonel-

I just spoke with Sgt. Lautigar about the hotel arrangements. He said Katie Pauly told him yesterday that he made a reservation at the St. Paul hotel for Sunday night. Sgt. Lautigar did not know what led to this decision other than the governor was apparently aware of the protest. The plan is for him to check in around 1400, go to his son's house to visit family after check in and make a decision about where he will stay the night on the way back. He will base this decision on level of activity at the residence.

Sgt. Krambeer will drive during the day and stay until 2000 if he goes to the hotel. Sgt. Lautigar will relieve Sgt. Krambeer at 2000 and remain at the hotel overnight.

Troopers Hoffman and Roddy will supplement Troopers Marks and Halvorson at the residence during the protest. Troopers Degler and Fox are on regular shift at the capitol and will be available if needed at the residence.

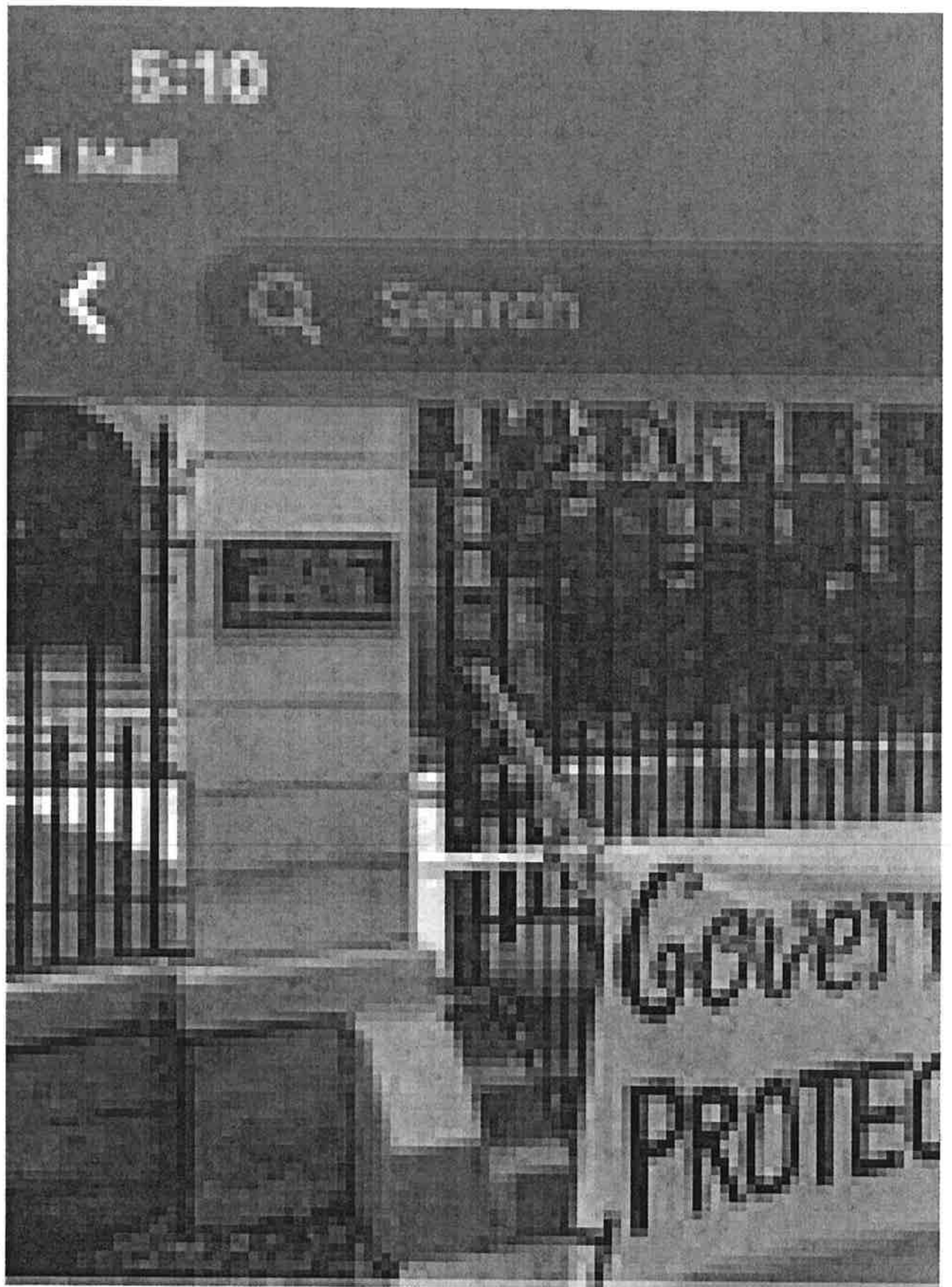

Major Huettl and Dawn,

Here is the District 2800 weekly update. Have a good week!

Operations

- On Friday, June 22 at approximately 2026 hours, a serious injury crash occurred at the intersection of USTH 71 and CSAH 9, north of Kabekona Corner in Hubbard County. A Toyota Camry traveling westbound on CSAH 9 failed to yield at the intersection and collided with a Dodge Dakota traveling southbound on USTH 71. A total of five were injured as a result of the crash with the most serious being an 8-year old girl that suffered internal bleeding. She was airlifted to Gillette Children's Hospital. Preliminary investigation points towards cell phone use (texting) as the primary causal factor. Trp. Brad Dingman is the primary trooper and Trp. Dion Pederson was assigned the crash reconstruction.
- An Aitkin County jury found the defendant, Tim Kostal, not guilty of careless driving as it related to the hit-and-run crash that killed Margaret Johnson on MNTH 47 in June 2016. Aitkin County Sheriff Scott Turner shared his conversation that he had with the jury foreperson after the four-day trial and the not guilty verdict hinged on the jury instructions delivered by the judge and not the presentation or testimony during the trial.

- A note of gratitude was passed along to Lieutenant Adam Fulton related to excellent service that Trp. Drew Olson (2800) provided at a crash scene: "I'm sure you don't hear it often enough, but THANK YOU so much for your assistance at the crash I was involved in on Saturday, June 16. We, as drivers, are lucky there are professionals such as yourself to take control of a situation and be informative and helpful to our ignorance. I am still dealing with insurance information, etc., but you telling me that the other driver had been cited has made this process much less complicated and frustrating than it could have been. The residents of your jurisdiction area can rest assured they have a very professional and courteous trooper on their side even though they may not treat you as they always should. Thank you, again. I know how lucky I was to have made your acquaintance." ~Glen Mecl
