# Introduction

Welcome readers! My name is WhiteCasper, I am the tech leader for National Socialist Legion (NSL). I am making this document for many reasons I shall not explain. Only those who know why this needs to be made. I am going to go into full detail on how our group will operate and run smoothly. This document will always be **changing or edited** to fit with our current times. Every member **MUST** read this document! There will be guidelines **everyone** will follow no matter who you are. If any rule is broken, they will be facing punishment. Everyone will follow our commands, if not then you don't need to stay. Thank you for reading, joining, and follow our guidelines. **THIS WILL NOT BE RELEASED TO ANYONE OUTSIDE OF NSL. UNTIL IT'S DECLASSIFIED. THIS GOES FOR ANY CONFIDENTIAL DOCUMENTS.**

Section 1.0(a) States:

(a) Security Information ("classified information") shall be classified at one of the following.

(b) Those who shall enter our group will NOT release **ANY** public information about themselves or our members. Those who commit these acts shall be treated with punishment.

(c) "Top Secret" shall be applied to information, the unauthorized disclosure of which reasonably could be expected to cause exceptionally grave damage to our security.

(d) "Secret" shall be applied to information, the unauthorized disclosure of which reasonably could be expected to cause serious damage to our security.

(e) "Confidential" shall be applied to information, the unauthorized disclosure of which reasonably could be expected to cause damage to our security.

(f) Those who release **ANY** chat, call, pictures, video calls, or logs to any "outsider" or third-party source will face punishment.

(Need to have leader consent)

(g) Anything that has **Confidential** on it. Will not leave our chats. If **Confidential** changes to **Declassified** it may be given openly. If abused or misused, the abuser will be punished.

(h) If anyone shares our manifesto with outsiders, you will be punished.

Section 1.1(b) States:

(a) Those who threaten, dox, harass, cyberstalk, etc. Will face **severe** punishment.

(b) Those who commit physical violence against one of our members will be brought attention of enforcement by (NSL).

(c) Those who disrespect any member of (NSL) will face punishment.

(d) Anyone who is religious, like me. Will **not** push their own agenda or religion onto others. You may discuss openly about it. However, for those who don't want to be religious doesn't need to be harass by others. This is a big problem within other groups and has even broken good ones apart.

Section 1.2(c) States:

(a) Every member will have at least **ONE** role when entering (NSL).

(b) That role **WILL** be based on your skill set. Do not have a role on which you can not complete.

(c) We have many roles to choose from when you are vetted.

Choose ONE, if later you want to:

(1) Change

(2) Add/Remove

Tell one of our leaders.

(d) Each role has one leader in your department. Every weekend

you **MUST** give:

(1) Proof

(2) Explain

(3) One form or another

Showing you have completed your task for that week. If you do **NOT** meet those standards your leader will decided on what **WILL** happen to you.

Section 1.3(d) States:

- (a) **Woman** who wish to enter will need to have a boyfriend or husband before entering. For woman who do not have one
  - (1) They can not join.
  - (2) Must find someone to be with.
- (b) We shall not have anything **against** NS or “pro cultural-marxism” in our group.
- (c) We will not have satanism activities, worship, or pro-satanism in our group.
- (d) NSL members and leaders will not tolerate any form of “**talk back**” from another member. They will be suspended.
- (e) In a case of Leadership abuse or power abuse, all other leaders will discuss punishment against them.
- (f) Woman who wish to enter needs to be accompanied by another woman that is already in our group.
- (g) You will **NOT** have any sexual relationship made with our group. **NOR** sex talk, flirting, etc.



Section 1.4(e) States:

- (a) In a case of feds obtaining logs, servers, chats, or anything dealing with technology, you must have a **Wire** account.
- (b) For those who get arrested, **YOU MUST ASAP** tell our leaders how and why you got arrested. This will result in a server “shutdown” meaning no posting until clear.
- (c) For those who get phones, computers, or daily use technology taken away from you, find a way to contact our leaders.
- (d) If you know before it’s going to be taken away from you **delete** all apps that is connected with (NSL).
- (e) In any form of a fed being able to get into our servers, we will need to shut it down. (If we know). Ex: FBI, CIA, etc. Our OPSEC will be targeted and broken easily by them.
- (f) Those who get arrested. You need to get out of jail? Great, NSL will back you up and raise money for you to help fund any problem you may face.

Section 1.5(f) States:

- (a) New members who have joined must read or listen to audiobooks that they will be provided with.
- (b) New members **MUST** have a basic level of intelligence with National Socialist or fascism before entering our group.
- (c) Those who do not know or have not read any books can not and will not join until completing tasks.
- (d) Any member who is lazy, will not complete tasks, does not care, etc. Will be kicked from our group as soon as possible.
- (e) Those who want to enter **MUST** complete our forms on our website under "Contact" page.
- (f) Anyone who **lies** about anything on our contact form will be removed as soon as possible.

# Requirements

- 1) Learn the life of a National Socialist.
- 2) Read Books bases around our ideology.
- 3) Be fit or get fit.
- 4) Must have a skill set. (In anything)
- 5) Must be active in our group. (Show **2-3 times** a week)
- 6) Must complete your role that you have chosen in vetting.
- 7) Have respect for members, leaders, or anyone within NSL.
- 8) No form of talking back to others within our group.

If not completed or follow our Requirements you will be removed.

- 9) Must be able to travel for meetups within your state.

# **Punishments Against Wrongdoings**

## **(PAW)**

Arrested = Kicked (until further notice)

Section 1.0(a) / (b) = 1-2 weeks suspended

Section 1.0(a) / (f) = 4 weeks suspended or up to Kicked

Section 1.0(a) / (g) = 5-6 weeks suspended

Section 1.1(b) / (a) = 5-6 weeks or Kicked

Section 1.1(b) / (b) = Kicked

Section 1.1(b) / (c) = 12-24 hours ban off server

Section 1.2(c) / (d) = Department Leadership decides

Section 1.3(d) / (d) = 2-3 hour no chat/voice on server

Section 1.4 / **ALL** = Kicked (Until further notice)

Section 1.5(f) / (d),(f) = Kicked

Section 1.3(d) / (g) = 24 hour ban

If a rule has been broken, which is higher than the others. The rule with the higher punishment will be given first no matter what.

# Vetting

Vetters! You are the line of defense for NSL. You will need to have a much harder vetting process. If you catch anything weird, inconsistent, or different about the person you are vetting they will be kicked. No matter what.

IF they lie, change story, or dievert into making you believe something that isn't true, they will be kicked. Everyone needs to go through vetting even if one of our members are “Friends” with them, even in real life. **EVERYONE NEEDS TO BE VETTED.** Vetters, if you do NOT follow these rules you will be held accountable.

You will **SAVE** everything when vetting. Chat logs and emails. As well time stamped and dated. For voice chat, you may record. However, you don't need to. But it will save many problems in the future. They will fill out the forum on our website **FIRST**. Wait until over twenty-four hours or longer until you can start the voice chat vetting. You many **NOT** give out any links from our servers etc.

# Communication

Communication in our group is **key**. You must always check in every week at least 2 to 3 times a week. See your leaders or State leaders to see if you are active. If not, you will be removed for inactivity and would have to go through the process of rejoining again. If you can not make it to a meeting with our chat tell our leaders or your state leader; with the reason why you can not show up. Also, be careful what you say within our chats. Do **NOT** dox yourself or any of our members. Including address, photos, names, or any personal information about you or our members. This will keep you safe as well our own group. Stated up above we take “leaks”, or anything that is classified seriously. If we see someone leak or give classified information out to anyone. You will be removed as soon as we get notified.

# Meetups

If you are attending any meeting in real life you are required to bring **one** or more of these things.

- (1) Hat, eyeglasses, bottom face mask (One or more)
- (2) Your State patch (If you have one) **(Required)**
- (3) Long shirt, pants, boots/shoes
- (4) Flag (If you have one)
- (5) Flyers, Stickers **(Required)**
- (6) Medical aid, First Aid **(Leaders & State Leaders Required)**

Number one is for safety reasons. No, we are not antifa or a communist who is actively looking for anarchy. This is for multiple reasons. One, not being doxxed by antifa or the left. Two, I assure you don't want cops at your door. Three, being found out and harassed daily by the opposing side. So please take into account that if you don't bring anything; you better be looking for a fight to come your way.

# Action

We need action! Go out with your freinds, leaders, or anyone from our group to spread our messages around. You may set up a meet up with members within our group. However, you need to tell the leaders and or your state leaders what you guys are going to do. And where you are going so we know beforehand. This is to help us understand what is going to be done, for example: flyers, stickers, videos, hiking, or any activity with NSL. We will not deny any of you not be able to meet. We should just know what your plans are. However, we do not agree with any “illegal” activity like killings. Although, if you do plan to do anything illegal be sure you are ready for what is coming your way. You must be active no matter what you choose for your role. You need to post at least once a month, and show proof of your actions. If you could not complete any actions, your state leaders may be able to punish you for not doing anything for our group.
