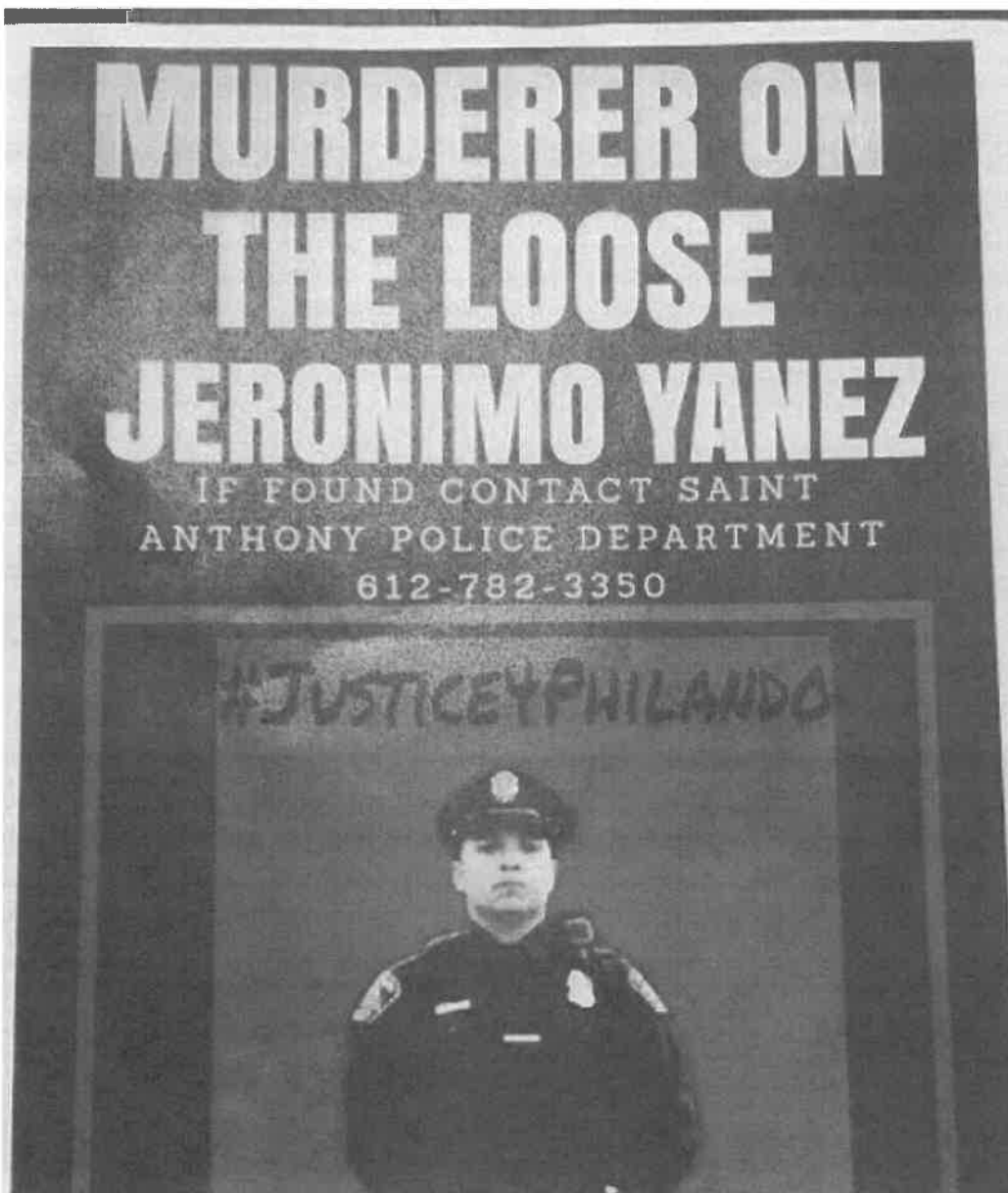

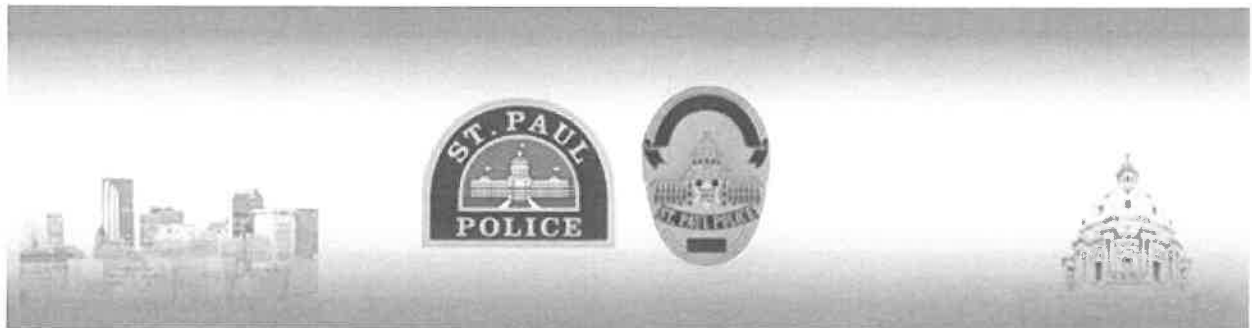

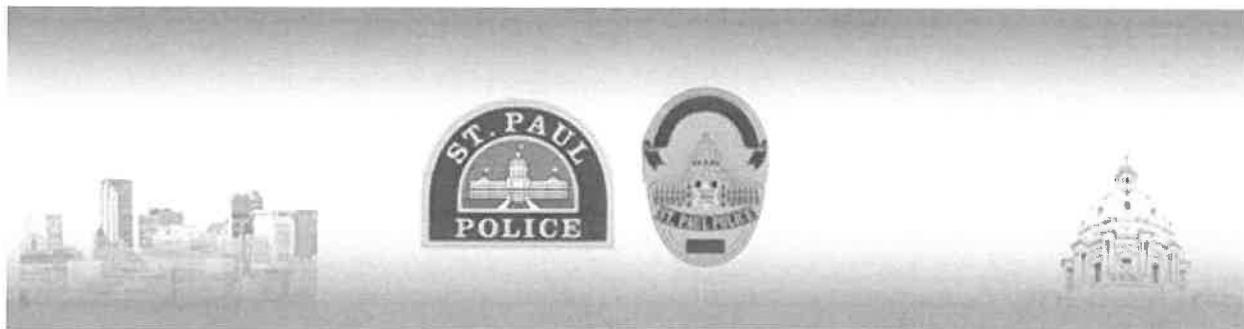

## **JUSTICE OCCUPATION FOR PHILANDO**

Please share this with your friends and if you can show up tonight to offer extra support.

We need people tonight and each night to show up and stay late (or overnight) to offer us more security and safety with numbers during the times of 2am-6am. If you can stop by and join us anytime please do. But tonight is an important night and here is why:

Each week Saint Paul police have tried overnight between Monday & Tuesday (usually between 2am - 6am Tuesday morning) to end our occupation.

The first time on Tuesday July 12, 2016 the police raided our camp at 2:30am "corralling" protestors into a corner, threatening arrest and causing a lot of trauma to young people peacefully protesting. The police threw away over \$5,000 of donated supplies including food, water, coolers, shade "tents", bedding, tables and many other items.

The second time at 6am on Tuesday July 19, 2016 the police showed up and told us they needed 12 hours to "clean the streets" and our protest area. This time we refused to leave after calling the Department Of Justice and confirming our rights to remain as a peaceful protest and negotiated instead to clean our own area. This time they opened the streets and created an unsafe environment allowing anyone with any agenda at anytime to drive through and potentially threaten and/or cause us harm.

We have endured the police refusing to allow our tarps to be unrolled and setup as shade tents in the grueling heat and also the police requiring us to remove and put tarps back up during torrential rain each time it stopped. We have endured a short period where we were told we could not sleep, sit down or set anything down. And finally we have endured police trying to control the amount of food and water that can be delivered to us. All in attempts to make us stop this occupation. But we have endured and will continue.

We have spirit and if the police try to move us we will rise again and come back stronger.

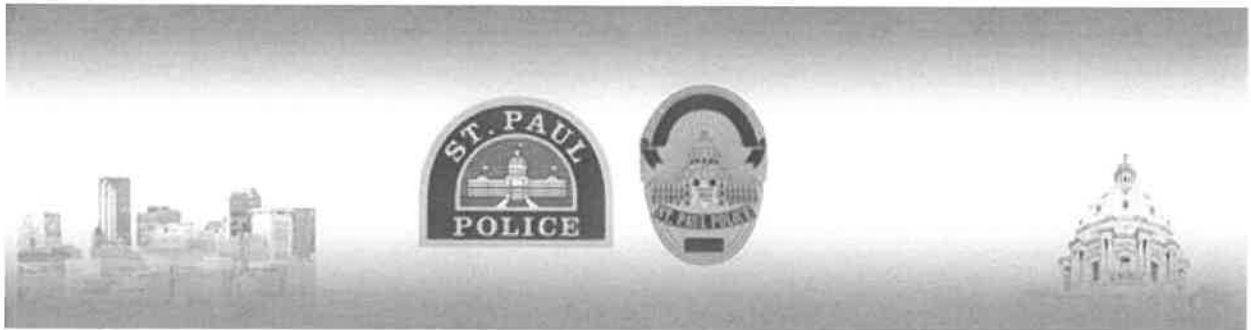

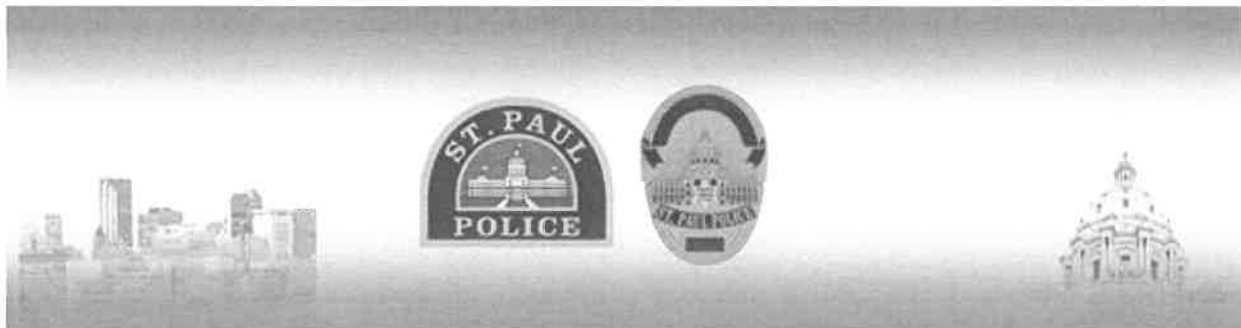

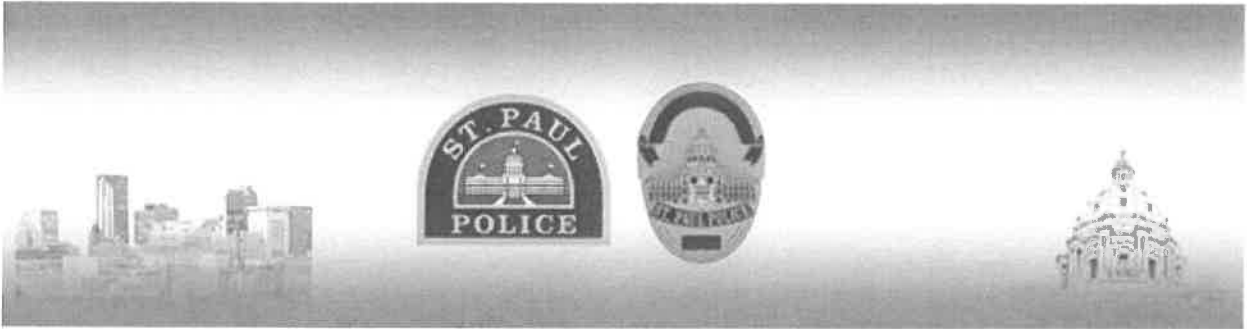
