Mission Description	1. Provides crowd management and crowd control, including: a. Saturation patrols b. Area search c. Perimeter control d. Staffing for traffic control points e. Resource Description	NSP will deploy 23 sworn Troopers made up of SWAT and Mobile Field Force along with leadership and logistics support. This team will include marked and unmarked transportation, a command vehicle and power generation. Lethal and less lethal force options are readily available by trained operators. Officers will be equipped in typical Mobile Field Force protective gear, protective masks, helmets and shields, with body worn cameras and compatible communications gear.

Equipment Requirements	NSP and MSP are coordinating communications capabilities. There may be a need for 23 radio's if our current radio capabilities are not compatible.

Equipment costs were built with the estimate that all consumable equipment (e.g. non-lethal crowd dispersion tools) will be depleted and replaced. In other words, this EMAC offer, includes an estimate of the maximum possible equipment cost, and (upon EMAC mission completion) the final cost will only include the equipment that is actually consumed and needs to be replaced.


