SENTENCE DETAILS: COUNT 1

Commit to Commissioner of Corrections

Ordered on May 31, 2023:

- Commit to Commissioner of Corrections at the MN Correctional Facility - St. Cloud for 150 months.

Sentence is stayed for 10 years.

This sentence consists of a minimum term of imprisonment equal to two-thirds of the total executed sentence, and a maximum supervised release term equal to one-third of the total executed sentence, unless the sentence is life or life without the possibility of release.

Local Confinement

Ordered on May 31, 2023:

- Defendant is sentenced to 364 days in the Ramsey County Correctional Facility.
Defendant is to serve 364 days on any and all programs, if eligible.

Credit for time served amount is 5 days.

- Deft. is authorized for any and all programming, if eligible. Start Date:
May 31, 2023

Monitoring

Ordered on May 31, 2023:

- Defendant is placed on supervised probation for 10 years, monitored by Ramsey County Probation.

Conditions

Ordered on May 31, 2023:

Defendant must comply with the following conditions:

- Follow all State and Federal criminal laws.
- Contact your probation officer as directed.
- Tell your probation officer within 72 hours if you have contact with law enforcement.
- Tell your probation officer within 72 hours if you are charged with any new crime.
- Tell your probation officer within 72 hours if you change your address, employment, or telephone number.
- Cooperate with the search of your person, residence, vehicle, workplace, property, and things as directed by your probation officer.
- Sign releases of information as directed.
- Give a DNA sample when directed.
- Do not use or possess firearms, ammunition or explosives
- Do not register to vote or vote until July 1, 2023 On that date, you have the right to register to vote and to vote during any time you are not incarcerated for this offense.
- Defendant is to participate in Mental Health Therapy.
- Take medications in the prescribed dosage and frequency
- Pay restitution

Ordered on May 31, 2023:

- Defendant is ordered to perform community work service of 150 hours per year in the 2nd thru 5th years of probation.
