PC Statement RE: 13.82 - Law Enforcement

During the course of this homicide investigation, Sgt Porras and I were able to view surveillance video from 2431 E Franklin Av. On this surveillance video, the images clearly show two males enter the Seward Hallah Market; both males had their faces concealed but each were wearing distinctive clothing.

Sgt Porras and I met with a concerned citizen who stated he had information about the murder at 2431 E Franklin Av. This concerned citizen told Sgt Porras and I he spoke with a male friend that gave him specific details regarding the sequence of events prior to, during and after the homicide at 2431 E Franklin Av. These details included businesses they went into in the hours prior to the shooting at 2431 E Franklin Av.

13.32 - Lew Enforcement of the concerned citizen was identified and transported to Room 108 for an interview. Post Miranda, the male friend of the concerned citizen told Sgt Porras and I 13.82 - Law Enforcement of his by the name of Mahdi Hassan Ali, dob 1-1-93 on 1-6-10. The friend of the concerned citizen said he and Mahdi and another identified male drove to the Mpls Impound Lot and then to the Super America on 22/Lyndale Av N.

Investigators obtained the surveillance video from the Mpls Impound Lot for 1-6-10. On that day at about 1600 hours, three males enter the impound lot building. One of these males was wearing clothing which was identical to that of one of the suspects who participated in the shootings that led to the deaths of three male victims at 2431 E Franklin Av.

During a post Miranda interview with Mahdi Hassan Ali, he told investigators while at the Mpls Impound Lot he was wearing clothing which matched the clothing of one of the suspects who participated in the above shooting. Sgts Kjos and Porras

Arriving officers found three

shooting victims and 2 witnesses inside the store. EMS responded and pronounced all three shooting victims doa.

Homicide Investigators responded to the scene along with MPD Crime Lab to record and recover forensic and video evidence. Witnesses were interviewed and told investigators 2 masked men entered the store, with one of the suspects walking up to the witnesses and ordering them to give him their phone and not to move. Witnesses said this suspect spoke to them in Somali but they did not believe he had a gun. Witnesses could only tell investigators this suspect was wearing a black mask to cover his face and his clothing was black.

Witnesses could give no description of the second suspect other than one witness thought the suspect was speaking in English. When a gunshot was heard, the witnesses said they ran toward the back of the business and hid until police arrived.

This store is equipped with surveillance video. Investigators reviewed the video from this store and saw at approximately 1943 hours, 2 males with their faces concealed, entered the store via the front door. One suspect was holding a gun and pointed it at the two store clerks seated at the front counter. This male was wearing a large gray hooded jacket, blue jeans cuffed at the bottom, what looked to be tan shoes and a light blue bandana covering his face. While watching the video, investigators could see red strings dangling down from under the hood of this jacket. These strings would flop around with each movement of the suspect's head.

The second suspect walked immediately toward the back of the store. This suspect was wearing a black hooded jacket, over a white and black horizontally striped shirt, dark blue or black jeans and white tennis shoes with black accents on sides and on top of the shoe. This suspect had what looked like a black "old style" ski mask on his face. This suspect walked to where the witnesses were and remained with them until running from the store, exiting out the front door.

While continuing to watch the store video, investigators saw the suspect holding the gun and wearing a grey hooded jacket, blue jeans cuffed at the bottom, tan shoes and a light blue bandana appear to be ordering the two store clerks out from behind the counter and down to the ground. At this same time, another male wearing a black jacket, black scarf and black rimmed glasses entered the store. Video images reveal upon entry of this person,

suspect with the gun and wearing the grey hooded jacket and light blue bandana turned and ran toward this male with the black rimmed glasses. The male wearing the black rimmed glasses fell to the ground and then one of the store clerks appeared to grab hold of the suspect with the gun as that suspect ran out of the store's front door. The next image shows that store clerk falling to the ground and only his feet can be seen moving slightly. At the same time investigators can see the suspect with the gun and wearing the grey hooded jacket and blue bandana can be seen running southbound on 25th Av S.

It was at that point the other suspect wearing the black hooded sweatshirt over a white and black horizontally striped shirt, dark jeans and white shoes can be seen running from the back of the store, jump over the two victims lying in front of this door and run southbound on 25th Av S. The second store clerk is seen removing his cell phone from his waistband and as he is attempting to dial his phone, the suspect with the gun and wearing the grey hooded jacket and light blue bandana can be seen running back into the store via the front door. The suspect with the gun and grey hooded jacket is seen running after the second store clerk as this clerk tries to flee further into the store. Video images show the suspect with the grey hooded jacket shoot at least on time at this clerk. This suspect then runs toward the front door, bending slightly toward the location where the black male with the black jacket and black rimmed glasses had fallen. This suspect then exits the store via the front door and can be seen running southbound on 25th Av S.

Within hours, investigators learn from a confidential reliable informant (CRI) 18 USC 2721 & 2725 told the CRI he has been casing the grocery store located at 2431 E Franklin Av. This CRI told investigators he did not know this male's name but did know he drives a black Chev Caprice with one window broken out. CRI said this Caprice is currently parked on the second level of the parking ramp belonging to 2515 S 9th St and it was facing the Wells Fargo Bank building. Investigators drove to this ramp and observed a dark colored Caprice with a broken passenger window facing the Wells Fargo Bank building. The license plate for the Caprice was

Through DVS it was learned that vehicle registered to 18 USC 2721 & 2725

On 1 7 10 investigators contacted management for 2515 S 9th St and was told the License was registered to the occupants of apartment #1319. Property Management told investigators a 16 year old male by the name of Mahdi Ali lives in this apartment with his 74 year old grandmother. Later on 1-7 09, Sgt Kjos answered a phone call from a male who said he was an employee 13.82 __aw Enforcement. This male said he heard of the murders at the Seward Market and said just one hour before that shooting, two males were in his 13.92 tawtmorement business. This caller said the two males were acting very suspicious, standing with their hands in their pockets and just looking around. The caller said he has video of the suspicious males and would like investigators to look at it. The caller was told investigators would get to his store as soon as possible.

On 1-8-10 learned of a concerned citizen who said he had information about the murders that happened at 2431 E Franklin Av on 1-6-09. This concerned citizen told investigators the names of two possible suspects that committed

the murders at Seward Market. Along with these names, this concerned citizen gave details about the events during the murders that only persons involved in the murders could possibly know. MPD VCAT officers located one of the persons the concerned citizen told

investigators about. Post Miranda,

13.82 - Law Enforcement

Sgt Porras went to the Super America on 22nd and Lyndale Av S and viewed their surveillance video from 1-6-10, beginning around 1600 hours. At about 1638 hours, from the video Sgt Porras sees a red Crown Vic pull up to one of the gas pumps. A black male wearing a black jacket, a white and black horizontally striped shirt, dark jeans and white tennis shoes with black accent exited the car and entered the store. As this same male entered the store, an image of his face was captured on two different interior surveillance cameras.

Sgts Folkens and Karokostas obtained the surveillance video from the Mpls Impound Lot for 1-6-10 beginning around 1600 hours and ending around 1615 hours. That disc was brought to Sgts Kjos and Porras who viewed the video. At about 1602 hours, three males can be seen entering the impound lot main lobby. The first male can be seen wearing a multi colored stocking hat which had shades of red and yellow and a tassel on top. This male was also wearing a black and grey coat, blue jean pants cuffed at the bottom and brown shoes. The second male entering the impound lot was wearing a black jacket over and white and black horizontally striped shirt, black pants and white shoes with black accents. The third male was wearing a dark colored stocking cap, a long black coat, dark pants and white tennis shoes. While watching this surveillance video, investigators could see the male with the multi colored stocking cap was conducting business with the impound lot staff.

Sgt Christopher House with Third Pct CRT went to 2025 Nicollet Av S and obtained surveillance video from 1-6-09 beginning at about 1815 hours and ending at about 1830 hours. Sgt House turned the surveillance DVD over to Sgt Kjos and Porras and reviewed the images provided. On the surveillance video, investigators noted the images were in black and white. 2 males can be seen walking in the hallway of this address. Both males have their hoods up and their hands in their pockets. As they walked down the hall, both males kept their heads bent downward. One of the males was wearing a light colored hooded jacket, pants that were cuffed at the bottom and light to medium colored shoes. The second male was wearing a dark hooded sweatshirt

over and white and dark colored horizontally striped shirt, dark pants and white shoes. These males were captured on several cameras at this location. VCAT officers arrested Mahdi Hassan Ali, dob 1-1-93 as he was returning home to 2515 S 9th St. Ali was brought to Room 108. Sqt Porras advised Ali of his rights per Miranda. Ali stated he understood each and every one of his rights. We asked Mahdi if he was aware of the murders that happened at the Seward Market on 1-6-10. Mahdi said he was and we asked him what he was doing that day. Mahdi said in the morning he took the bus and train to renew his DL then later in the day he went to Elliot Park to play basketball. Mahdi said at about 4-4:30, he called his friend Abdi (unknown last) for a ride. Abdi arrived in a black Chev Caprice with his girlfriend Marian. Mahdi said his friend drove him to the Mpls Impound Lot where he attempted to get his car out. After that, Mahdi said they drove straight to St Paul where he stayed until 8 or 8:30 that night. Sgts Porras and Kjos told Mahdi we had surveillance footage from several businesses which show he is lying to us. At that point, Mahdi said when he went to the Mpls Impound Lot, as he was walking in he ran into some old friends named Abdi Ali and Ahmed Ali. Mahdi said Abdi and Ahmed also came into the impound lot to conduct business. Mahdi said he left Abdi and Ahmed at the impound lot and went to St Paul with Abdi (different from Abdi Ali) and Abdi's girlfriend, Marian. Sqts Kjos and Porras again told Mahdi we knew he was lying because we have video surveillance from other businesses. At that point, Mahdi said he was now going to tell us the truth. Mahdi said he was driving the red Crown Vic on 1-6-10. Mahdi said he did pick up Ahmed Ali and Abdi Ali from their school, Volunteers of America. Mahdi said they drove to the Mpls Impound Lot and all three went in. While at the impound lot, Mahdi said he tried to get a car out but was not successful. They left and drove to the Super America on 22nd and Lyndale Av S. Mahdi said he pulled up to the gas pumps and Ahmed got out of the car to pay for the gas. After that, Mahdi said they drove to Nicollet and Franklin and parked in an alley behind a big building. Mahdi said he and Ahmed got out of the car and Abdi stayed inside his red Crown Vic. Mahdi said he and Ahmed were just talking then a one point Ahmed walked toward Starbucks. Mahdi said he didn't know where Ahmed went but several minutes later he returned and they left. Mahdi said they next drove to Abdi's house on Clinton Av S and dropped him off for the night. Next, Mahdi said he went to Ahmed's home on 38th and Hiawatha and let him off at the Super USA. Mahdi said the car he was driving belongs to his friend Amir who was working at Fairview Riverside Hospital. Mahdi said he picked up Amir from work at about 2000 hours and " they drove to "Fridley" to buy some marijuana. Please note, we asked Mahdi if he smoked any of this marijuana and he said no. Mahdi further stated he hasn't smoked marijuana for 4 or 5 days. After buying the marijuana, Mahdi said Amir brought him home to 2515 S 9th St. Sgts Kjos and Porras determined Mahdi was continuing to lie about his whereabouts on the evening of 1-6-10. Mahdi Hassan Ali, dob 1-1-93 was

Drought down to Juvenile Division and booked for PC Murder. After compiling all the video evidence, Sgts Kjös and Porras compared the clothing worn by the suspects in the murder at Seward Market on 1-6-10 to the images captured on the surveillance videos retrieved from the Mpls

Impound Lot, SA at 22nd/Lyndale Av S and the business located at 2025 Nicollet Av S.

Sqts Kjos and Porras noted significant similarities between the clothing worn by the suspects inside the Seward Market and the clothing worn by Mahdi Ali and Ahmed Ali while at the Mpls Impound Lot. Further, significant similarities between the clothing worn by the suspect who immediately walked toward the back of the store and the clothing worn by Ahmed Ali while inside the Super America at 22nd and Lyndale Av. Finally, significant similarities were noted between the clothing worn by the suspects in the Seward Market shootings and the clothing worn by the males walking in the hallways of 2025 Nicollet Av S. - Please note, the images of the males walking through 2025 Nicollet Av S was captured just over one hour before the shooting the resulted in the death of three men at Seward Market. On 1-9-10 Sqts Porras and Kjos went to Henn JDC to interview Mahdi Ali. Once in an interview room it was explained we wanted to show Mahdi surveillance footage captured on 1-6-10 to verify the locations he visited on that day and the persons he was with. Before this, Sgt Porras again advised Mahdi of his rights per Miranda. Mahdi said he understood and would like to look at the surveillance videos we brought with. First Mahdi was shown the Mpls Impound Lot footage. The camera angle of the lobby and front desk was brought up on the screen and the date and time stamp was 1-6-10 and 5:00 pm. Please note, the time stamp for this video is off by one hour so 5 pm will actually be 4 pm. On this video, it showed three men walk toward the service desk. Mahdi pointed to the shorter male wearing a red multi colored hat, black and grey sweater and blue jeans cuffed at the bottom and said that was him. Mahdi pointed to the tallest and thinner of the males and said that was Ahmed Ali. The male he said was Ahmed was wear a black coat over a white and black horizontally striped shirt, black pants and white tennis shoes with black accents. Mahdi lastly pointed to the male wearing the long jacket and said that was Abdi Ali. Sgts Porras and Kjos asked Mahdi if the hat he was wearing had strings hanging from the sides and he said it did. Sqt Porras asked if Mahdi ever tied these strings under his chin and he stated no. Next we showed Mahdi the surveillance footage of the Super America store at 22nd and Lyndale Av S. The first image was of a male walking into the store wearing a black coat and white and black horizontally striped shirt. Mahdi pointed at that screen and said that is Ahmed. The next image shown was of a red car pulling into the parking lot and a black male in a black coat exiting the car. Mahdi said that was his friend Amir's car but he was driving it on this day.

Lastly we showed Mahdi the surveillance footage from 2025 Nicollet Av S. The image of a male wearing a black hooded sweatshirt over a white and black horizontally striped shirt walking down a hallway was shown to Mahdi. Mahdi said he didn't know who this person was because his face was concealed by the raised hood and the down turned head. We asked Mahdi if he was certain he didn't know who that was and Mahdi responded, "I don't know who that is but I am sure it is not Ahmed."

Sgts Kjos and Porras received information Ahmed-Shire Ali's family was at the 3rd Pct. We were told they had Ahmed with them and wanted to speak with

investigators. Ahmed was transported to Room 108. At about 0003 hours on 1-10-10, Sgt Porras advised Ahmed of his rights per Miranda. Ahmed stated he did understand his rights and did not want to talk to us as his family is getting him a lawyer. The interview was ended. Ahmed-Shire Abdi Ali, dob 3-1-92 was brought down to the MPD Juvenile Division and booked PC Murder. Sgts Kjos and Porras Homicide Unit

On 1-6-10 at about 2000 hours, Sgt Porras contacted me regarding a shooting in south Minneapolis. Sgt Porras said officers were on scene at 2431 E Franklin Av and have 3 male victims DOA. Because Sgt Porras and I were the on call team, we immediately responded into the city.

While en route, Sgt Porras called to say he would respond to the scene. It was decided I would go to Room 108 and prepare interview room for the two witnesses who were at the scene at the time of this shooting.

Sgt Porras returned to the office and briefed me on the scene. I was told the shooting happened inside the Seward Halah Market, 2431 E Franklin Av. It was explained this store does have a working security system which records images from at least 10 different cameras. Sgt Porras said Crime Lab is on scene and forensic staff are attempting to retrieve the surveillance video for the minutes before, during and after the shootings. At about 2115 hours, uniformed officers brought in Jamiila Ali Ahmed, dob

Jamiila was placed in interview room M. Please note this room is equipped to both video and audio record our conversation. Our conversation in brief:

Jamiila said she lives in a different city but is in this area frequently to visit her mother and shop at the Somali stores. Jamiila said she went into Seward Market to get some Somali coffee. When she entered the store, she saw two clerks sitting behind the cash register counter and an older male cleaning the floors. Jamiila said one of the clerks directed her to the back of the store when she asked about the Somali coffee. The older gentleman then walked over to help her find it.

Jamiila said all most immediately a tall Somali male with a mask covering his face was standing next to her. Jamiila said she heard someone yell we are getting robbed. Jamiila said the masked male spoke in Somali to her and the old man demanding they give him their cell phone. Jamiila said she begged him not to hurt her and the masked man apparently said he wasn't going to kill her just give me your phone.

Jamiila said she then hears a loud pop and the masked man by her ran away from them. Jamiila said at that point as she and the old man ran to the back of the store, she heard two more gun shots. Jamiila stated they ran into the freezer and hid. Jamiila said she called the police and didn't come out until they got there.

I asked Jamiila to describe the masked man that was trying to take her phone and she said he was taller then her, very skinny and about 20 years old. Jamiila said she could not remember any of the clothing that suspect was wearing.

We learned the second witness, Youb Wako Ala, dob 1-1-17 speaks very little English. Officer Mohamed Abdullahi speaks fluent Somali and we requested he come to Room 108 to assist with translating during our interview with Youb. At about 2200 hours, Sgt Porras, Officer Abdullahi and I went into interview

room F to talk with Youb. This room is equipped to both audio and video record our conversation. The interview in brief: Youb said he is always at the Seward Market, helping with cleaning the store and visiting with the clerks. On 1-6-10, Youb said there were two clerks behind the cash register counter when a female customer came in. This female (here further referred to as Witness/Jamiila) asked for Somali coffee and Youb walked toward the back of the store to assist her.

Youb said he heard someone yelling robbery then a black male wearing a mask started grabbing him and going through his pockets. Youb said he could hear yelling toward the front of the store, further stating they were yelling/talking in English. Youb said he could not understand what they were saying but he next heard 2 gunshots. Youb said he and Jamiila ran to the back of the store and hid in the freezer until police arrived. Please note, Youb stated he is missing his wallet but doesn't know if the suspect took or if he lost it somewhere in the store.

I asked Youb if he could describe the suspect(s) and he said there were two of them; one was tall and the other was shorter and stocky. Youb said the shorter suspect was yelling at the clerks while the tall suspect was grabbing at him trying to get his phone. Youb could only describe the clothing the suspects were wearing as "all dark". Sgt Ann Kjos Homicide Unit

Regarding Initial response to 2431 East Franklin On 01-06-2010, at approximately 2000 hours I was contacted by Sgt Karakostas who told me that they were at 2431 East Franklin on the scene of a triple homicide. I told Sgt Karakostas that I would be contacting Sgt Kjos and that we would be responding from home.

On this same date at approximately 2040 hours, I arrive at 2431 East Franklin (Seward Market). I observe several squads with their overhead lights blocking traffic from driving by the crime scene and yellow crime scene tape is also up to protect the integrity of the crime scene. I meet with a uniformed Minneapolis Police Officer who is maintaining the crime scene log. After I get logged in, I walk west towards the Seward Market and meet up with Sgt Folkens who is standing just outside the front door of the Market. The Seward Market has all of its lights on inside and I'm told by Sgt Folkens that they have several of cameras inside and that they are working on getting that video surveillance as soon as possible.

As Sgt Folkens is explaining the crime scene and the details he knows up to that point, I observe one black male laying face down on the sidewalk just in front of the front door of the Seward Market with a large pool of BLS near his head.

Still outside on the sidewalk, I look inside the store from the front door and see another black male laying face down near the counter area. Sgt Folkens tells me that there is another victim inside the store and that we will enter from the side door. Sgt Folkens walks me south on the sidewalk area and we enter thru the side door which is located on the east side of the business. As Sgt Folkens and I enter the east side door, there is a kitchen type area to my left and there are aisles of products to my right. It should be noted that the isles run in a north south direction.

Once inside, I looked towards the north (front of the store) and saw another black male laying face down with a food rack tipped over with several bags of chips, snacks etc on the floor near him.

I then walk up to the front of the store and meet with Sgt Karakostas. He tells me that there are several cameras in the store that work and they are working to get the video surveillance. Sgt Karakostas shows me some DCC's near the victim closest to the counter, cash register area.

I learn from Sgt's Folkens and Karakostas that there were two possible witnesses in the store at the time of the murders. I told them to have them to have them transported to Room 108. I then contacted Sgt Kjos and told her that I was leaving the crime scene and there were two possible witnesses that needed to be interviewed and that I would meet her at Room 108 to assist in these interviews.

While at Room 108 I meet Faysal Hussein Warfa. Mr. Warfa tells me that he

Karakostas, regarding a possible triple homicide in the Third Precinct. I contacted Sqt. Karakostas who informed that indeed there was a triple homicide at 2431 Franklin Ave East and he asked that I respond to assist with gathering media. By 2045 I had received several calls from local media on the case. I arrived at the scene around 2100 hours where I was briefed by homicide investigators and the street supervisor, Sgt Pleoger. I then conducted a media briefing on the case. I stayed at the scene and continued to provide assistance to both the media and command staff until approximately midnight. I was within the outer perimeter of the scene but at no time did I cross the inner perimeter or enter the store where the crime had occurred. While at the scene I was approached by a male who told me that a woman in the crowd might have suspect information. I interviewed this woman briefly and turned over her contact information and a brief synopsis of what she had told me to the case investigators, Sergeants A. Kjos and L. Porras. On Thursday, January 7 2010, I attended the vigil for the victims along with Chief Dolan. Shortly after arriving at the scene I noted that traffic was gridlocked around the location. I contacted the street supervisor on duty, Sgt. Pleoger, and asked that he provide resources to deal with the issue. He told me that there were no squads available due to stacked priority 1 calls. Later in the evening I assisted Inspector Gerold, Lt. Ostlund and two patrol officers in traffic control around the event. After it appeared that the traffic problem was resolved the Inspector, the Lt and the patrol officers cleared but the traffic problem re-emerged. I then spent approximately 45 minutes directing traffic in the area. Over the next few days I was contacted numerous times by multiple local and national news organizations surrounding this case. On Friday January 8th I was in the Chief's office when I was approached by Julie Sikora (Chief of Patrol's secretary) who informed me that there was a man in the Admin Office lobby who wanted to speak with an officer. I had a conversation with this male and he provided what I felt to be credible information regarding this case. I contacted Sqt. A. Kjos and arranged for this man to meet with her. Following the first arrest in this case I conducted on-camera interviews on Saturday 1-i0-2010 with all major media outlets. On Sunday, January 11th, at the request of Chief Allen I arranged a press conference for the Chief and the Mayor to discuss developments in the case including the arrest of a second suspect.

On Wednesday, January 13, 2010 I was contacted by a local reporter covering the case. He informed me he thought case investigators should contact the business owner for a follow-up on an issue. I passed this along to the investigators.

The first system was a "Network DMR" 13.82-Law Enforcement that was connected to a monitor behind the front counter of the business. This system was connected to nine cameras (seven views from the interior of the business and two exterior views) and appeared to be recording from all of them. The second system was a "CIB" MPEG4 9 Channel DVR Ser 13.82 - Law Enforcement This system was connected to eight (8) active cameras and monitored in the basement area. The camera views were three interior views of an adjoining building and five exterior views from around both buildings.

At the location attempts were made to retrieve images of the event however the systems could not be accessed for review of any recorded images. Sgt. Folkens advised me to recover the systems for analysis in the Video Analysis section of the Crime Lab.

Both systems with power cords were recovered and brought to the Lab. After reviewing the system operation of the "Network DMR" the system was accessed with stored images beginning on 1-5-10 at approximately 1030hours. While the system was playing four of the camera views were recorded to DVD beginning at 1130 on 1-5 until just before the business closed at 9pm.

The system was then moved ahead to 1-6-10 and the time of the event which according to the time stamp was 1943hours. Video relating to the event was copied into the Avid system from seven (7) of the nine cameras. (The additional two camera views contained no images from the incident) The recorded views were placed in a timeline and burned to two DVD's. The DVD copies of the event and the DVD of the views from 1-5-10 were turned over to Sgt. Kjos and Sgt. Porras who had been assigned to this case. 1-7-10 an additional copy of the event was made from the Avid system timeline for inventory. This was the same as the copies previously given to Sgt. Kjos and Sgt. Porras. Two DVD copies, from 4 camera views of the day's events 1-6-10, were made from the DVR system. At the time stamp of 22:42:30 a vehicle is observed north on 25th Avenue lights on. This vehicle makes a U turn just prior to the alley in the rear of the business and parks. At 2330 hours, Sgt Porras, Officer Abdullahi and I responded to 2431 E Franklin Av. Arriving we met with Sgt Folkens who brought us into this store through the east door. A kitchen area is immediately to the left or south and the main part of the store was to the right or north. Walking to the front of the store, we noted one male lying on the floor near a food rack, a second male lying on the floor with his head near the cashier counter and a third male lying in the doorway.

MPD Crime Lab was on scene, collecting evidence and attempting to recover the stores surveillance video. We were told the DVR for the surveillance system was password protected and currently no one was able to identify what that password was. It was later decided the store's two surveillance DVRs would be brought back to the Crime Lab so the images could be viewed and downloaded to DVDs.

After leaving the scene, Officer Abdullahi spoke to a Confidential Reliable Informant (CRI) with ties to the Somali community. After speaking with the CRI, Officer Abdullahi said the CRI heard of the shootings at the Seward Market and remembered a Somali male speaking of that store within the last month. This male apparently told the CRI he has been "casing" the Seward Market because he knows they wire money to Somalia. Because of the money wire business, the male apparently believed The Seward Market will have large amounts of money in the store.

The CRI did not know the Somali males name but said he drives a dark colored Caprice with a broken window. This Somali male apparently lives close to the Seward Market and parks his Caprice on the second level of his apartment buildings parking ramp. The CRI stated the Caprice is usually parked in a stall close to the Wells Fargo Bank.

We drove north on 26th Av S and noted a two level parking ramp sandwiched between the Seward Towers located at 2515 S 9th St and the Wells Fargo Bank on E Franklin Av. Driving up to the second level of this ramp, we noted a dark colored Chev Caprice, MN Lic 012-BWM parked in one of the southern most stalls, right next to the Wells Fargo Bank building. This Caprice had a broken front passenger side window that was covered with black plastic. Once back at the office, DVS was checked and investigators learned. Lic

Messages were left with Seward Towers management, requesting they call investigators about MN Lic 012-BWM parked on their property. Sgt Porras and I met briefly with Officer Abdullahi's CRI. The CRI told us he quite often speaks with many of the young males in the Somali community. The CRI said within the past month, a male who he is familiar with but does not know his name came to him to say he has been looking at a business to rob. This male told the CRI the business is a block from where he lives and he knows the business wires money to Somalia. The male told the CRI because of the money wiring, he felt they would have a lot of cash in the store.

The CRI went over again what kind of car this male drives and where he parks it. I then asked the CRI to describe this male and he said he is about 20 years old, has a dark complexion and has deep-set eyes. Early in the morning on 1-7-10, Sgt Porras and I met with Cliff Johnson in the MPD Crime Lab. Mr Johnson was able to download images from the Seward Market surveillance video. Viewing these images we were able to see two black males enter the store at about 1943 hours. These males had their faces concealed and one was holding a gun. From watching the video, it was noted the male with the gun shot the three victims inside the store. The two suspects fled the store, running southbound on 25th Av S. Please note, the suspect with the gun can be seen wearing a grey hooded jacket. The hood on this jacket is up and there are colored strings dangling out from under this raised hood. The suspect with the gun is also wearing blue jean pants and a light blue bandana or scarf over his face. The second suspect is wearing a black hooded sweatshirt. 

Abdi Salan. Mr A said Abdi told him he was in the store when the murders took place. According the Mr A, Abdi said he and another male by the name of Mahdi went into the store to rob it but it went bad. Mr A said Mahdi lives in the Seward Towers and drives a black Caprice Classic but on the night of the murders, they were in a red Crown Victoria. Mr A said Abdi told him when the robbery went bad, he ran from the store. As he went through the door, Abdi apparently said he needed to jump over two bodies. Mr A further said he was told one of the clerks tried to grab Mahdi and that's when Mahdi shot that clerk.

We were able to obtain a recent picture of Abdisalan Ahmed Ali, dob 3-10-94 and showed it to Mr A. Immediately Mr A said this is the Abdi that told him he was in the store at the time of the murders and needed to jump over two bodies to get out of the store.

Sgt Porras and I showed Mr A a picture of Mahdi Hassan Ali, dob 1-1-93. Immediately Mr A said that is the Mahdi he knows and is positive this is the Mahdi Abdi was referring to.

Mr A stated Abdi said there was a male by the name of Ahmed Shire waiting in the car and may have been the driver of the red Crown Vic.

We asked Mr A if he knew where Abdi lived and he said 2912 Clinton Av S. Other investigators gueried our MPD CAPRs and learned a male by the name of Abdisalan Ahmed Ali, dob 3-10-94 13.82 - Law Enforcement Abdisalan 13.82 - Law Enforcement (See CCN 09-369846)

We asked Sgt Folkens and Sgt Karakostas to draft search warrants for and 2515 S 9th St, #1310, both addresses in the City of Minneapolis.

MPD VCAT were sent to that address and asked to attempt to pick up Abdisalan Ali and if there, bring him to Room 108. Within the hour, Sgt Porras and I were contacted by VCAT stating they found Abdisalan at his home and he was willing to come down and talk to us. A contact number for Bonnie is 6 . Bonnie was able to access their stores surveillance footage for 1-6-10. At approximately 16:38:02 a red Ford Crown Victoria can be seen arriving into the lot and parking near gas pump one. A black male is seen exiting the front passenger seat of this red Crown Vic and entering the store. This male is seen wearing black coat over a white shirt and black jeans. At approximately 16:39:10 this same black male with the black jacket can be seen entering the store underneath camera number 5. This male is seen walking through the store toward the cash registers. Supplement of Sgt A.Kjos #004898 on 01/19/2010 16:52 VCAT brought Mahdi Ali to Room 108 and placed him in Room F. This room is equipped to audio and video record our conversation. Please see the CD of the interview for complete details. Our interview in brief: At about 2230 hours, Sgt Porras advised Mahdi of his rights per Miranda. Mahdi said he understood each and every one of his rights. Sgt Porras and I asked Mahdi if he knew of the 3 persons shot and killed at the store near where he lives and he said he did. We told him we received information he may have been involved in the shooting and we wanted to know where was on 1-6-10.

Mahdi initially told investigators on 1-6-10 rode the bus to apply for a new DL and update the license plates on a vehicle he had in impound. Mahdi said he went home then took the bus to the Brian Coyle Center to play basketball. Mahdi said at about 1630 hours, his friend Abdi (unknown last name) and Abdi's girlfriend Marian picked him up in Abdi's black Chev Caprice. Mahdi said they all went to Abdi's home in St. Paul and stayed until he came home around 2030 hours.

Sgt Porras and I confronted Mahdi with the fact we have several business video which show he was not in St Paul during the time he says but rather in Mpls. With that Mahdi said he wanted to start over and tell us the truth. Mahdi said he was driving a red Ford Crown Victoria that day first going to apply for a new DL and then to the Government Center to update a vehicle registration.

Mahdi said at one point he picked up his friend Ahmed Ali and Ahmed's cousin Abdi from their school. With them, they drove down to the Mpls Impound Lot to try and get a vehicle of his out of impound. Mahdi said they didn't have enough money and left. Mahdi said they next drove to the Super America at 22nd/Lyndale Av S to get gas. Mahdi said he was still driving and pulled up to one of the pumps while Ahmed got out paying for \$5 worth of gas. Mahdi said they next drove down to Nicollet and Franklin Av S. He and Ahmed got out of the car while Abdi remained inside. Mahdi said he and Ahmed talked about personal things then Ahmed walked toward Starbucks. Mahdi said when Ahmed came back to the car; he first took Abdi home then dropped Ahmed off near his home at 38th and Minnehaha Av S.

After dropping Ahmed, Mahdi said he drove to Abdi (last name unknown LNU) home in St Paul. Mahdi said Abdi (LNU) lives on Maryland Av off I-35E but could not give us any other details as to where he lives. Mahdi did tell us Abdi's phone number, for a line of the set of the set of the male at that number who identified himself as Abdi. Abdi said he does know Mahdi and would come and speak with investigators as soon as can be arranged. Mahdi denied any involvement or specific knowledge of the murders at 2431 E Franklin Av. Mahdi was walked down to MPD Juvenile Division where he was processed as part of his arrest for PC Murder. Mahdi was later transported to JDC via MPD Juvenile Division.

On 1-9-10 a search warrant was drafted requesting the courts allow us to search the red Ford Crown Victoria, MN Lic TPJ-926. This warrant was brought to the honorable Judge Belois who after review signed the document. Sgt Porras met with MPD Crime Lab at the MPD Forensic Garage. Sgt Porras presented a copy of the signed warrant to FS McDougall. Sgt Porras stood by as the car was photographed, both inside and out.

Forensically, Crime Lab swabbed for BLS, biological swabs and processed areas for latent fingerprints. Recovered from the car is a pair of tan boots from the trunk of this car; miscellaneous paperwork from the trunk area; miscellaneous paperwork from the interior of the car and finally a receipt from Super America dated 1-6-2010 with a time of 2122 hours. This receipt includes the address of the Super America as being 6545 W River Road, Brooklyn Center, MN. Also noted on the receipt is the transaction number of 872701 which was in the amount of \$2.03. This purchase was made at register 3 and the type of payment was by a VISA card ending in the numbers 1382

Sgt Kjos met with George Hewitt, who is an employee of the Mpls Impound Lot. I learned Mr Hewitt dealt with Mahdi Ali on two different occasions in the past week. Mr Hewitt said on January 4th or 5th, Mahdi Ali came in to the impound lot to retrieve his Chev Caprice that is currently in their lot. Mahdi Ali apparently only had an expired Employment Authorization card which his boss, Brian Heins wouldn't except as valid identification.

Mr Hewitt said Mahdi Ali returned to the impound lot on 1-6-10 with two other men. This time, Mr Hewitt said Mahdi had a yellow temporary DL that was timed and dated earlier this same day. Mr Hewitt said his boss, Brian Heins accepted this as a form of identification but then Mahdi didn't have enough money to get the car out.

Mr Hewitt said he did not conduct any business with the other two males dealing only with Mahdi. I asked Mr Hewitt to describe what Mahdi was wearing that day and he said he had on a multi colored hat that almost looked handmade. Mr Hewitt said Mahdi was shorter then the other two males with him but could give no further details about his clothing or build. Before leaving, I was given a copy of all the paperwork compiled during the two interactions Mr Hewitt had with Mahdi Ali. This paperwork was later property inventoried at the MPD Property and Evidence Room.

At about 1945 hours, Sgt Kjos and I went to the Super America on W River Road. We spoke with the Assistant Manager Liz Warren who assisted us in viewing and later retrieving surveillance footage from the night of 1-6-10. These images include a red Crown Victoria arriving at the store at about 2120 hours. A black male is seen exiting the front passenger seat of this Crown Vic and entering the Super America store. The video reveals this male is wearing a grey coat with a black strip on the arms of the coat. The male

in the grey coat can be seen making a purchase at the register then leaves the store.

Please note, while looking at the CD given to us by Liz Warren, it did not appear the images of the male wearing a grey coat making a purchase at register 3 was on the disc.

Sgt Porras contacted the corporate offices of Super America and spoke with Carla Clay. Ms Clay told Sgt Porras the name of the card used on the above transaction is Amir Farah.

This same day at about 2345 hours, Sgt Granger contacted Sgt Porras and I stating he was down at 3rd Pct when a Somalian family entered the station. It was learned they were the family of Ahmed-Shire Abdi Ali. After speaking with us, Sgts Granger and Dale brought Ahmed to Room 108 for an interview. The recording equipment for interview room F was activated. At about 0003 hours, Sgt Porras advised Ahmed of his rights per Miranda. Ahmed said he understood each of his rights but would like to have his family's lawyer with him before he talked to us. At that point we ended the interview and left the room.

Sgt Porras and I met with Ahmed's family, to include his father Abdi Jama; his mother, Hawa Yusuf and his sister, Hani Abdi Ali. This conversation took place inside interview room M. The recording equipment was activated before we spoke with them.

Hani translated for all of us as Sgt Porras and I explained why their son Ahmed had been arrested and we would be presenting the case to the Hennepin County Attorney's Office for charging. We asked Mr Jama and Ms Yusuf when the last saw Ahmed and were told he went to school on Wednesday, 1-6-10 and he hasn't returned since. We were told Mr Jama had been looking for Ahmed and finally found him this evening in St Paul.

We asked Hani to ask Mr Jama if Ahmed said anything to him about the three murders at the Seward Market. Mr. Jama said Ahmed only said "I did not shoot them". We were told they were in the process of finding a lawyer for Ahmed and would call us if and when they were able to retain one. Sgts Porras and Folkens brought Ahmed to MPD Juvenile Division where he was processed and later booked into Henn JDC for PC Murder. Sgts Kjos and Porras MPD Homicide Unit

At about 1200 hours, Sgt Kjos contacted Mahamed Mur, the President of Dahabshiil, a money transfer business located at 2025 Nicollet Av S. Mr Mur stated he is the building manager for 2025 Nicollet Av S. Mr Mur said this building consists of several businesses located on the two levels. Mr Mur said the building is equipped with surveillance cameras which cover the hallways and some of the businesses.

Mr Mur said on 1-6-10 another business emloyee by the name of Kadra Ahmed told him two males were walking the hallways. According to Kadra these men were looking into businesses and seemed to be "casing" them. Mr Mur said Kadra thought one of these males was wearing a mask. The males had left the building before anyone from building management could speak with them. Sgt Porras and I arranged a time when we could meet with Kadra and speak with her directly.

At about 1600 hours, Sgt Prras and I met with Mahdi Ali at the Hennepin County JDC. Before speaking with Mahdi, I activated my digital recorder. Sgt Porras advised Mahdi of his rights per Miranda. Mahdi stated he understood each and every one of his rights. We asked Mahdi if he would look at some surveillance video we brought with and he stated he would. Please see a transcript of this interview. Our conversation in brief: Using a laptop computer, Sgt Kjos put in the footage from the Mpls Impound Lot surveillance cameras. Looking at the images, Mahdi confirmed for Sgt Porras and I the shorter male wearing the red multicolored hat which also had strings was him. Mahdi said the other two males with him were Ahmed Ali and his cousin Abdi. Mahdi pointed to the male wearing the longer coat and a stocking hat and said that is Abdi. The third male wearing a short black coat is Ahmed.

We next put in the surveillance footage from the Super America on 22nd/Lyndale Av S. Showing Mahdi the images from inside the store, we played the video of a male wearing a black jacket over a white and black horizontally striped shirt entering the store. Mahdi told Sgt Porras and I that was Ahmed.

We then played the footage from the SA lot and after seeing a red car pull up to the gas pumps, Mahdi said that is the red Ford Crown Victoria he was driving on 1-6-10.

Lastly, we played the surveillance footage from the building located at 2025 Nicollet Av S. We showed Mahdi the video we have of one male walking down the hallway. This male was wearing a black hooded sweatshirt over a white and black horizontally striped shirt. We asked Mahdi if he knew who this was and he said he did not. We asked if he was sure and Mahdi said he didn't know who that was but it was definitely not Ahmed. At that point we ended the interview. Sgts Kjos and Porras

South and I walked down the alley towards the north and then took the T going east towards and I was headed for SEWARD CO-OP and as I got behind the SEWARD MARKET I heard what I, a loud bang what I thought might be a shot and as I started to get to the sidewalk and then to the street 25th Avenue I saw someone, I saw a puff of smoke near the doorway and someone exiting and I believe I saw someone else exit that didn't move but one person started coming towards me and it was very very dark and I could not either they were, they were either very dark skinned or wearing a mask. I don't know which but I couldn't see any details and they started proceeding south on 25th. I decided I should get out of the way of this person thinking if it was a shot they had a gun and I ran to the west - to the east. I ran east down the alley behind next to EMMANUAL LUTHERN CHURCH then I cut immediately up north, cut north through their parking lot to Franklin Avenue and then I started going back towards going east towards SEWARD MARKET. I saw two other people coming down the sidewalk towards me. They reached the market before I did. They crossed 25th Avenue very quickly coming towards me and they then told me that there were bodies there; that their phones didn't work I should call 911. And I did that as I was crossing the street and then I was at SEWARD MARKET and saw the body and also some people in the back of the market that didn't look threatening or dangerous. But they were they were in the back of the market. The guy that was running towards you you said that he was dark could you 0. tell what kind clothing he was wearing? I would say a winter jacket you know just a standard some sort of R. standard winter jacket. It was very it was just too dark to see any detail at this point. And then you say there may have been a second person. Q. Yeah. In the back of my mind I think I saw someone else standing by the R. doorway as this guy was coming towards me. And was he running towards you. 0.

R. Yes well not quite a full out run but not walking so sort of jogging. I

almost would say he was a little bit hobbled or maybe limping to something. I don't know but he wasn't running real fast. I don't even know if it was a man really but I assume since the suspect is a man it probably was. He wasn't running very fast more like jogging and I did not want to confront this person and if they did have a gun but I did want to get back to the market to see if there was anything wrong. And then as you said you ran across 25th to the east did anybody follow Q. you? R. Not that no I would say no because I did check behind me as I was running and I was very I couldn't run very fast. I had a full loaded pack with a computer with a computer it in on my back and Sorrel boots on my feet but it wasn't like I was running a marathon here and I looked back once and there was no one there and that's when I thought I should make my way to Franklin right away because it would be safer to be on Franklin at this point. Okay. SGT PORRAS did you have any questions? Ο. SGT PORRAS Q. Did you see them when they ran did you ever keep an eye on them? Do you know how they left the area? No I don't. And I assume and I told the dispatch I told 911 that they R. went south on 25th that was my assumption but afterwards I realized they could have turned down the alley behind SEWARD MARKET. SGT KJOS But once you went east. Q. Yeah I would say they probably went down 25th because I did look back R. once and I didn't see anybody in the alley behind SEWARD MARKET but you know I may have missed it too so. SGT KJOS Can you think of any thing we didn't ask you sir? Ο. R. No. That's about I can remember. Do you remember how many gunshots you heard? Q. At about 0700 hours, Sgt Kjos property inventoried several pieces of evidence to include the surveillance videos from 22nd/Lyndale Av S - Super America; Mpls Impound Lot and the Super America on W River Road in Brooklyn Center. Also inventoried was a DVD containing the surveillance footage from the Seward Market, 2431 E Franklin Av on 1-5-10. DVDs of our interviews with Witnesses Jamiila Ali Ahmed and Youb Wako Ala were inventoried as well. Also placed in inventory was the clothing and property recovered during the arrest of Mahdi Ali and the clothing and property recovered during the arrest of Ahmed-Shire Ali. Finally, copies of documents from the Mpls Impound Lot were inventoried.

I then called Fairview Riverside Hospital and spoke with Kathy, the manager of Nutrition Services (1997). I asked about Amir Farah and if he worked on 1-6-10. Kathy said he is an employee and did work; punching in to work at 1556 hours and punching out of work at 1936 hours.

Next I spoke with Ryan Luipke (612 who knew of Amir Farah. We asked Ryan to check their hospital surveillance cameras and attempt to see what time Amir left work that day and if he was picked up by someone in a red car.

Ryan was able to confirm via surveillance footage, Amir Farah was at Fairview Riverside until approximately 2030 hours. Images confirming this were sent to me via email along with an image of a red car near the exit Amir left out of.

This same day at about 1000 hours, Sgt Porras and I spoke via phone with Mahdi's aunt Ayan Abukar. We explained we wanted to interview Mahdi's grandmother, Sainab Osman and asked if she could translate for us. Ms Abukar said she could and it was decided we would bring Ms Osman to Ms Abukar's home.

Once at Ms Abukar's home, we asked Ms Osman how long Mahdi has been living with her. We were told Mahdi's parents have married other people and he is no longer close to them. Mahdi has been living with Ms Osman for the past couple years. We asked Ms Osman if she was a customer of the Seward Market and she said she was. Ms Osman said she knows the men who run the store very well, continuing to say they would deliver food to her apartment when she wasn't able to go outside. We asked Ms Osman if Mahdi was a customer of the Seward Market and she said she wasn't sure.

On the night of 1-6-10, we asked Ms Osman if Mahdi was at home and she said he was not. Ms Abukar said she was visiting Ms Osman that evening and when the news came on, they learned of the shootings at the Seward Market. Ms Abukar said they stood outside for quite awhile then went back to Ms Osman's apartment. As they were entering, Ms Abukar said Ms Osman's phone was ringing. This call was missed but almost immediately, Ms Abukar said she got a call on her cell phone from Mahdi. Mahdi told her he was in St Paul

and would be home soon.

We confirmed Ms Abukar's cell phone number is 612 . Ms Abukar said Mahdi called from phone number 612 . Ms Abukar believed she received this call around 10pm. Ms Osman said Mahdi came home around midnight. Ms Osman said she couldn't say what Mahdi was wearing when he came home because she was upset and crying over the deaths of the men at the Seward Market.

Via phone, I spoke with the Seward Towers Maintenance Supervisor George Wood and asked when their outdoor garbage is picked up. Mr Wood said because of the large number of apartments in their building, their garbage is picked up every Monday, Wednesday, Friday and Saturday.

Sgt Porras and I next met with Kadra Ahmed at her place of work, 2025 Nicollet Av S, #205. On 1-6-10 Ms Ahmed said she was working at her travel business located on the second floor of 2025 Nicollet Av S. Ms Ahmed said she stepped into the hallway just as two young males were walking past her. Ms Ahmed said the first male to pass was shorter and older then the second. She further said his face was not covered but she could not describe it. Ms Ahmed said the second male was tall and skinny, young and wearing a black jacket. Ms Ahmed said as the tall male passed her, he pulled his hood over his face so she couldn't see what he looked like.

Prior to this interview, Officer John Hawes sent me photographs of several Somali males. With these photos, I was able to create two 6 person photo line-ups; one line up with Mahdi Hassan Ali, dob 1-1-93 and the other with Ahmed-Shire Abdi Ali, dob 3-1-92.

Ms Ahmed said she did see the face of the shorter male. This physical description is consistent with the physical description of Mahdi Hassan Ali. I showed Ms Ahmed the 6 person line-up with Mahdi Ali pictured in one of the photos. After looking at each photograph, Ms Ahmed said she could not say for certain if any of the persons pictured is one of the males she saw in the hallway of her business on 1-6-10.

Ms Ahmed said after the two males walked through the building, they turned and left. She tried to see where they went but lost them once she got to the street level.

At about 1510 hours, I requested MPD V-CAT go to Volunteers of America, Abdisalan Ali's school and ask Abdi if he will come to our office. While at the school, I asked Officer Sherri Peterson to retrieve the surveillance video that school has for 1-7-10.

Once at our offices, we place Abdi in interview room M. We told Abdi we felt he was lying to us and he said again he was not. Abdi said he never talked to 13.62 or anyone about what had happened at the Seward Market because he said he didn't know what happened. Abdi said again Mahdi picked he and Ahmed up from school, they drove to the coat factory in North Mpls, then to the Impound Lot and to the SA on 22nd/Lyndale. Abdi said they next drove to Nicollet and Franklin where both Mahdi and Ahmed got out of the

car. Both were gone for several minutes. When Mahdi and Ahmed returned, Abdi said they stood outside the car and talked for several more minutes. Abdi said he became very impatient because he needed to get home before his dad or he would be in trouble.

At that point, I drove Abdi to Nicollet and Franklin Av and had Abdi show me exactly where they parked when there. Abdi pointed to 2025 Nicollet Av S and said when they first arrived, Mahdi tried to park in the parking lot next to this building but it was full. As he pulled out, Abdi said Mahdi drove across Nicollet to the parking lot just to the south of Starbucks. Abdi said Mahdi drove through this lot and into the alley between Nicollet and Blaisdell, then parking behind an apartment building with a Blaisdell address.

I drove this route and noted where Abdi said they parked was quite a ways from 2025 Nicollet Av S. I asked Abdi what Mahdi and Ahmed were wearing when they left the car. Abdi said he had gotten a new coat from the coat factory and told Mahdi he could have his coat. At that time, Abdi said Mahdi was wearing his big grey coat and had a hat on. Abdi continued to say Mahdi was wearing the hat inside-out so the black side was out and the red side was in. Abdi continued to describe the hat as having strings which hang down from the sides. When asked about Ahmed, Abdi said he thought he was wearing a black hooded jacket. Abdi didn't know if Ahmed had a hat on or not.

As I was taking Abdi home, Abdi said when Mahdi dropped him off on 1-6-10, he pulled into the lot and turned around near the north end of the building. I noted there was a security camera above a door on the north end of this building. I went to the store and spoke with the Store Manager Luke Lukkonen. Mr Lukkonen said he would contact their district manager and order the video for January 6th, 2010 between the times of 1830 and 1940 hours.

I have left several messages with Matt, the District Manager for Mpls Auto Zone regarding the surveillance footage but as of 1-20-10 have not gotten a response.

I was contacted by Cliff Johnson with the MPD Crime Lab regarding video from the DVR taken from Child Care Services 2511 E Franklin Av. Mr Johnson said the requested video covering the alley behind this facility was copied and the DVR unit can be returned. In CAPRs, I released the DVR, signed it out and returned it to Child Care Services.

Sgt Porras received a phone call from a family member of V/Anwar Mohammed asking if they could have the keys to Anwar's car. Please note, video evidence shows Anwar parked his car on 25th Av S just south of E Franklin Av seconds before entering the Seward Market. The car wasn't moved until all photo and video processing could be completed.

Sgt Porras and I went to the Hennepin County ME's Office and asked if we could see the personal property belonging to Anwar Mohammed. I was handed a bag containing a billfold which included credit cards, MN DL in the name of Anwar Mohammed and misc papers; glasses, keys, lottery tickets, jewelry and \$27.57 were also inside this bag. I signed an Inventory Report for the property belonging to Anwar Salah Mohammed, ME CCN 10-0060 and allowed to take custody of the property.

Sgt Porras and I then met with Anwar's bother-in-law Basha Saed Salah, dob 12-26-60 outside his work at Fairview Riverside Hospital and gave him Anwar's property.

Sgt Porras and I met with Amir Farah at his place of employment, Fairview Riverside Hospital. After speaking with him briefly, it was decided Amir would come to our offices for an interview.

I received a phone call from Cliff Johnson, MPD Crime Lab who said he has been reviewing the surveillance video which covers the exterior of the Seward Market. Mr Johnson said one camera faces SB and covers south of the building down 25th Av S. I was told the time stamp on the video is not accurate but Mr Johnson was able to find the video footage which corresponded to the time of the shootings.

I was told a car can be seen driving NB on 25th Av, make a u-turn and park facing SB. Apparently, while parking, defects can be detected in the backing car's back-up lights. Sgt Timmerman, MPD Crime Lab - Forensic Garage video taped an exam of the red Ford Crown Victoria we have held in this case.

On 1-13-10 at about 1530 hours, I again met with Abdisalan Ali in our offices. This interview took place in room O which audio and video recorded our conversation. Please see a transcript for complete details. Our conversation in brief:

I showed Abdi my digital recorder and explained I wanted to do get a quick question and answer statement (Q/A) from him. Abdi said he did not want to give a recorded statement but did answer all my questions again. Abdi said while at Nicollet Av S and E Franklin Av, he remained in the red Crown Vic

which was parked in an alley. Abdi said Mahdi said he needed to do something and Ahmed said he would go with. When asked what Mahdi was wearing, Abdi said Mahdi was wearing his big grey coat and a black hat with strings down the sides.

After leaving, Abdi directed us to the coat factory he, Mahdi and Ahmed went to on 1-6-10. We arrived at 1312 Glenwood Av N, Mpls and I went inside to ask about the stores video surveillance system.

I noted the store name is the Coat Factory and as I entered I saw a camera covering the main entrance. I spoke with the Assistant Manager, Christa and explained I was interested in three males who were in her store on 1-6-10. Christa said she remembered the males because one of them tried to steal a coat. Christa said the three entered and two went walking through the coat selections while the third stayed by the cash registers asking questions. After a few minutes, Christa said two of the males walked out but as the third tall, skinny male attempted to leave, their alarms activated. Christa said she confronted the male and demanded he return the coat he was stealing. Eventually Christa said she was able to get the stolen coat and allowed this male to leave. Christa if they were missing any other merchandise and she said she noticed the next morning one other coat was stolen on 1-6-10.

I showed Christa a picture of Ahmed-Shire Abdi Ali, 3-1-92 and she immediately said this is the male who attempted to take the coat. I next showed Christa a picture of Abdisalan Ali and Mahdi Hassan Ali, dob 1-1-93 and she said she remembers both of them being in the store when the first male I showed her was trying to steal a coat.

I asked Christa if I could get a copy of the surveillance footage for 1-6-10. Christa said the manager, Toni, would have to do that and would let her know in the morning about our request.

I learned later, the Coat Factory's video surveillance system is not currently working and their DVR did not capture any images for 1-6-10. At about 1930 hours, Sgt Porras and I met with Amir Farah in Room 108. We spoke with Amir in room M. This room is equipped to audio and video record the conversation. Please see Sgt Porras report for a brief summery of this interview.

Sgt Porras and I were notified by Assistant Hennepin County Prosecutor Bob Streitz who said he was contacted by Mr. Paul Edlund regarding Ahmed-Shire Abdi Ali, dob 3 1-92. We were told Mr Edlund is an attorney representing Ahmed and Ahmed wishes to speak with investigators regarding the shootings at the Seward Market on 1-6 10.

As agreed upon by attorneys Bob Strietz and Paul Edlund, on 1-14 10 at about 0730 hours, Sgt Porras and I went to Hennepin County JDC, signed out Ahmed-Shire Abdi Ali and brought him to CID. Ahmed was placed in interview room F. This room is equipped to audio and video record all conversations. At about 0800 hours, Mr Paul Edlund arrived and was given an office so he and Ahmed could speak privately. At about 0830 hours, Sgt Porras and I along with Mr Edlund entered Room F. We briefly told Ahmed we wanted to talk to him about the murders at the Seward Market on 1-6-10. Before asking him questions and in his attorney's presence, Sgt Porras advised Ahmed of his rights per Miranda. Ahmed said he understood each of his rights and would answer our questions.

In brief: Ahmed said on 1-6-10 he and his cousin Abdisalan (Abdi) Ali were picked up from school by Mahdi Ali. Mahdi was driving a red Ford Crown Victoria and visited several businesses to include the Mpls Impound Lot, a gas station and a check cashing business down on Nicollet Av S and Franklin Av. Ahmed said he and Mahdi went into the check cashing business with the intention of robbing it but left when they saw there were too many people in there.

After leaving the area of Nicollet Av S and Franklin Av, Ahmed said they took Abdi home. Ahmed said they drove to the area of the Seward Market and it was decided they would rob that store. Ahmed said as they walked toward the store, he put a mask over his head and Mahdi covered his face with a light blue bandana. Ahmed said before entering the market, Mahdi pulled a gun out. Ahmed said his role in the robbery was to keep control of any customers or witnesses.

Ahmed said there was a woman and an older man in the store at the time of the robbery. Ahmed said he was standing by them while Mahdi was up front. Ahmed said he heard a gunshot and immediately ran to the doors. At the door, Ahmed said he saw two bodies lying on the ground. He said he had to climb over them to get out and ran south from the store. Ahmed said at first he didn't know where he was and couldn't find the car. He said he ran back north and got into the red Ford Crown Vic just as Mahdi was getting in. Ahmed said he immediately took off his mask and asked Mahdi why he shot those people. According to Ahmed, Mahdi told him the people in the store knew who he was and when Mahdi tried to run, the clerks grabbed him. Ahmed said Mahdi drove to a parking ramp where they sat for about 10 minutes. Ahmed stated he asked Mahdi to drive him home and was dropped off




