MODIFICATION NO. 1

Dear Purchaser:

Please refer to your Salmon Run Timber Sale contract No. ORM07-TS-2023.0014. On April 9, 2024, during a site visit to Unit 32-25, your representatives, Mr. Brian Sutch and Mr. Kyle Syfert, discussed with the project engineer the need for Temp Route 32-25-A and Temp Route 32-25-B as identified in the contract and flagged on the ground. The conclusion was that only Temp Route 32-25-B will be necessary for harvesting this portion of the Unit, but all construction activities will ensure the avoidance and disturbance of the large diameter trees adjacent to Temp Route 32-25-B's clearing limits. Additionally, Temp Route 32-25-A will not be necessary to harvest that portion of the unit and will be removed from the contract.

Modification 1 changes Exhibits C & D portions of the contract, which includes the deletion of the Temp Route 32-25-A (440 linear feet) into Unit 32-25 off the 33-5-31.1 Road. These changes include:

Deletes Temp Route 32-25-A

Deletes 440 linear feet of temp route construction

(\$3.894.67)

• Deletes decommissioning requirement (water bars and barricade) (\$603.89)

Removes \$4,498.56 from the construction and maintenance appraisal allotments.

Adds Spot Rocking on the Miller Gulch Road System

• Spot rock the Miller Gulch Road system to the sum of \$4,498.56 with 1.5"-minus crushed rock per contract specifications. Contract cost per CY of 1.5"-minus crushed rock material averaged \$58.08 which calculates to approximately 77.5 CY's.

Adds \$4,498.56 to the construction appraisal allotment.

Modification No. 1 results in a zero-dollar modification.

All other terms and conditions of your contract shall remain in full force and effect.
