I believe there is probable cause to charge the defendant with these charges because:

On June 14th 2025, at 19:56 hours gunfire was reported at a large rally involving several thousand people in downtown Salt Lake City at 151 South State Street. Three shots were fired and one male was fatally struck by a round. Salt Lake City Police Officers quickly responded and were informed that a male dressed in all black clothing and a black mask covering his face was seen running north and then east through the block. Officers responded to that area and were guided to 100 S 200 E to a male crouching down among a small crowd of people. This male, A/P Arturo Gamboa, was found in possession of an AR-15 style rifle, a gas mask, black clothing, and a backpack. The A/P also had a minor through and through gunshot wound to his left side.

Other police officers in the area located 2 males in yellow high visibility vests with handguns in their possession. These 2 males are part of the "peacekeeping" group assigned to assist the planned protest/rally in ensuring everyone's safety. These 2 males were cooperative with officers and investigating detectives. In interviews with one of the peacekeepers it was discovered that he observed Arturo move away from the main crowd to a secluded area behind a wall. The peacekeepers found this behavior to be suspicious and kept Arturo in view. One of the peacekeepers observed Arturo remove an AR-15 style rifle from a backpack he was carrying. He observed Arturo begin to manipulate the rifle and they called out to him to drop the gun after drawing their own firearms. Arturo then lifted the rifle, and according to witnesses he began to run toward the large crowd gathered on State Street holding the rifle in a firing position.

One of the peacekeepers fired 3 rounds at Arturo as he ran toward the large crowd. One of the rounds fired struck a male in the crowd, causing a fatal wound. The peacekeepers then attempted to provide medical aid to the victim, who was pronounced dead at the hospital. Arturo Gamboa was acting under circumstances evidencing a depraved indifference to human life, and knowingly engages in conduct that creates a grave risk of death to another individual and thereby causes the death of the other individual.

I believe these to be additional condition(s) for continued detention:

The current offense is a felony. There is substantial evidence to support the charge, and through clear and convincing evidence ? would constitute a substantial danger to another individual or to the community, or is likely to flee the jurisdiction of the court if released on bail.
