in order to cause the ball attendees to evacuate the building as a result of the smell of the Butyric acid. Your affiant has learned that Butyric acid can cause severe vomiting, respiratory problems, skin irritation, and temporary loss of vision, among other affects. Defendant stated that he would build a device that would be used to disperse the Butyric acid. The Second plan was to set off the building's fire alarms and deploy the Butyric acid inside the heating and air conditioning ventilation system in order to render the floor/building unusable and have the event/party goers evacuated from the building. The man who the Witness knew to be Defendant stated that he would spray the Butyric acid "all over." The Defendants planned on transporting the Butyric acid into the National Press Club by buying tickets to the event and smuggling the Butyric acid in a purse or container. All three defendants discussed the best method of dispersing the Butyric acid throughout the building. The defendants discussed doing a reconnaissance of the National Press Club to determine where to release the Butyric acid. The three Defendants also discussed plans to have a small group armed with water guns waiting outside to spray the event/party goers once they were outside, and subsequently planning to escape before the arrival of the police. The Witness also provided the Defendants' names, telephone numbers and an email address for the three Defendants.
