### LAW ENFORCEMENT SENSITIVE

The below information was provided voluntary by concerned citizens, and was exclusive of law enforcement involvement. It discusses potential criminal activity surrounding the Inaugural Events. Groups or individuals mentioned are done so as they were provided by a civilian entity operating on their own accord, and they are listed due to the potential criminal activity. Information is not listed to maintain or keep records on any 1st Amendment activities.

On Friday, 1/13/2017, at approximately 0900 hours, members of the FBI WFO JTTF met with Attorney Benjamin Barr and three members of the group Project Veritas, who had infiltrated the Disrupt J20 protest on their own accord and had been attending planning meetings. The members contacted the FBI due to concerning information obtained in the planning meetings involving criminal activity surrounding INAUG.

The following is a summary of the events discussed and planned leading up to the Inauguration:

On Saturday, 1/14 - Monday, 1/16, Disrupt J20 will be hosting a direct action training camp at American University (AU). The location was secured by one of the Disrupt J20 activists, \_\_\_\_\_\_, and will be held at the \_\_\_\_\_. Self

Defense classes are being taught, as well as resisting arrest tactics. Training is provided under the guise of "protecting oneself if attacked by Trump supporters," but the primary goal is actually how to resist arrest. The Activists discussed that the tactics would potentially be used on law enforcement, but they have to publically promote it as being against Trump Supporters so as not to draw the attention of local police. Attendee estimates are from 200-250. Disrupt J20 activists do not anticipate any interference from MPD, as they believe MPD Officers will sympathize with the anti-Trump sentiment.

On 1/17 - 1/18, Disrupt J20 activists discussed conducting dry run protests in WDC and on the highways leading into WDC to see local law enforcement response. Disrupt J20 made mentions during meetings of trying to bus in folks on 1/17 and 1/18 due to their intent to "shut down" avenues of ingress for WDC.

On Thursday, 1/19, the DC Antifascist movement and Disrupt J20 plan on infiltrating the DeploraBall, being hosted at the National Press Club. The group has obtained two tickets for the Ball, and discussed deploying stink bombs in the building or in the air system. Also discussed was deploying the sprinkler system. The goal is to force attendees to exit the building, where they will be met by protesters outside who intend on spraying them with squirt guns filled with water and possibly urine. In tandem with the DeploraBall event, protesters plan on distracting the police by staging an unspecified event at the Trump Hotel to pull attention away the National Press Club. Numbers are estimated at 50+, but there is NFI. In order to smuggle the stink bombs into the DeploraBall, it was discussed that a purse will be used.

- is described as having long unkempt hair and "always barefoot" Another possible conspirator is described as an old man with a Santa-style white beard, "beer belly," yellow teeth, and a "dirty beanie" on his head. His role in UNK, but appears to act as a quasi-security guard during meetings.

On Friday, 1/20, members discussed their intent to shut down the WDC to prevent the INAUG. They will utilize three waves:

- \* Wave 1: block the highways leading into WDC, with a focus on Virginia travel and ingress/egress points
- \* Wave 2: will stagger themselves into entry points into the Inauguration route to avoid law enforcement detection, and intend to block the entry points with human chains, possibly handcuffing themselves.
- \* Wave 3: intends to shut down the Metro Stations. Three Metro Stations are being targeted: Metro Center, L'Enfant Plaza, and Gallery Place. Members plan on chaining the locations to prevent entry/exit, and chaining the metro trains to fixed objects so the conductors will not be able to leave the station.
