

(SECOND LETTER) February 6, 2025

Dear Unicorn Riot:

Now I'll prove how the United States government censors anarchists in the federal prison system.

I'm incarcerated in FCI McKean of the Federal Bureau of Prisons. FCI McKean has banned all books, magazines, newspapers, newsletters, zines, pamphlets, etc. for the second time already! See Exhibit "A," annexed hereto and made a part hereof, for the ban bulletin of FCI McKean. (Sorry, I do a lot of legal work.)

At least during the first book ban this prison allowed me to receive the News Roundup newsletter since they just photocopied it like a regular letter. But because the News Roundup newsletter from Midwest Books to Prisoners contains anti-prison,

pro-anarchy, pro-activist content, this prison used this second book ban as an excuse to completely and totally ban the News Roundup anarchist newsletter since I was getting anarchist information from it to contact organizations and groups such as yours for help with my three tortures. The United States government even violates its own constitution just to censor anarchist material!

And because I had e-mailed myriad organizations and groups for help with my 3 tortures, the warden ~~of~~ **+** this prison then banned my e-mail access forever, deleted all my contacts, deleted all my Corrlinks e-mail addresses, and even blocked your mailing address when I tried to add it! See Exhibit "B," annexed hereto, for my November 2, 2024,

diatribe/harangue to the prison warden
of FCI McKean for her deletion of my 99
contacts, 24 phone numbers, and 18 e-mail
addresses.

Also, see Exhibit "C," for the
Federal Bureau of Prisons deleting my 28
contacts, 10 e-mail addresses, and 6 phone
numbers back on May 31, 2024, in order to
stop me from contacting legal organizations
about FCI McKean's first book ban in
April 2024 and to stop me from contacting
lawyers about the police torturing me for a
forced confession that left me with severe,
permanent injuries.

Worse, on October 31, 2024, when
I mailed a 6-page letter to my mother
about FCI McKean's multiple book bans,
FCI McKean deleting all my contacts and taking
away my e-mail access forever, FCI McKean's
deliberate indifference to inmates getting

severely stabbed for using the phones, FCI McKean's insipid food, et cetera, the prison guards intentionally confiscated the 6 pages, then sent out the envelope unsealed! See Exhibit "D," annexed hereto, for my mother's November 5, 2024, letter about the unsealed envelope she received. Then see Exhibit "E," annexed hereto, for my mother's November 7, 2024, letter to the prison warden about the unsealed envelope she received.

As if this wasn't enough, FCI McKean just won't quit censoring me! I rewrote my letter but made it 7 pages this time to make it different and gave it to a prison guard to mail out on November 14, 2024. My 7-page letter also went out unsealed for the second time in a row! These ~~F~~**BOP** guards had the temerity to mail out my two letters unsealed just because I told my mother about their numerous acts of egregious misconduct. See

Exhibit "F," annexed hereto, for my mother's November 19, 2024, letter about the second unsealed envelope she received. Talk about prison censorship!

Please kindly spread the word about the United States Bureau of Prisons' foregoing acts of censorship and misconduct so that our people can see that prison is really as bad as they see on TV. You have my permission to use any of my pages in this letter to share with everyone. Spread the **message** on your Web site and everywhere else that the **USBOP** is getting away with illegal book bans, anarchist newsletter bans, e-mail censorship, snail-mail censorship, stopping me from getting anarchist materials, and stopping me from getting help for the 3 **tortures** in my first letter. Let's expose the United States of Censorship!

I hope you can reply back to my second letter, and let me know what you think. I look forward to hearing from you, and thank you kindly indeed for your response!

On October 18, 2024, you, Warden A. Newman, deleted all of my 99 contacts, deleted 24 phone numbers, and deleted 18 e-mail addresses including attorneys John F. Mizner, Jeremy Gordon, Brandon Sample, et alia, and also including (prison) law firms such as the National Lawyers Guild, Rights Behind Bars, Lewisburg Prison Project, Pennsylvania Institutional Law Project, etc. Then you denied me e-mail access forever in toto. Then you put me on this arbitrary preapproval of new contacts, so when I tried to add Midwest Books to Prisoners and Chris Rad (from the Prison Legal News advertisements) you still denied them both!

The spurious reasons you gave for deleting all my contacts are (1) the false allegation that I have a GoFundMe page (which I don't currently) and (2) that I have social-media pages which is my CONSTITUTIONAL right to have people update even while I'm in prison. The federal Bureau of Prisons ("fBOP") has NO authority over social-media sites, because quite simply, you're just a prison. You don't control the Internet. I have a First Amendment right to post about unfair and illegal prison conditions such as your recent complete book ban, magazine ban, and newspaper ban. I have a First Amendment right to post about your unfair, unconstitutional months-long lockdowns that deny me law-library access and deny me the right to make photocopies of my legal work.

And I've done NOTHING wrong at all! I have NOT been sanctioned for any incident report. I have NOT received any notice of your arbitrary deletion of my contacts and denial of my e-mail access forever.

You just want to silence me for fighting your book ban, magazine ban, newspaper, ban, months-long lockdowns, etc. You just want to censor me and try to stop me from posting my police-torture on social media. Of course, you cannot stop me, because I have a right to do all these LEGAL things.

On October 29, 2024, when you called me over to pat me down, you had stated you did not know who I was. That's a prevarication. Then when I asked you if I can just log into my e-mail account to print off old e-mails since my e-mail was denied forever, you were rude and told me to file a grievance. No problem. A prisoner has the right to exhaust his administrative remedies prior to filing a civil action in the United States District Court for the Western District of Pennsylvania, 17 S. Park Row, Room A-150, Erie, Pennsylvania, 16501. Have a resplendent day!

Per our verbal conversation on Tuesday, June 4, 2024, you explicated that I have been put on "contact preapproval status," which means the SIS department of FCI McKean must approve my contacts first before I can add them to my contact list. Of course, I vehemently oppose this, since I've done NOTHING wrong. I assert that the reason for this "contact preapproval status" is to block me from contacting attorneys to help me with the police-torture in my criminal case which I was wrongfully convicted of.

Please answer my question: Can SIS just deny any of my contacts for any reason, arbitrary or not?

And please remember that the FBOP CTU wrongfully deleted my contact info@BadJurist.com (back in early March 2024) without providing me any notice whatsoever. I did NOTHING wrong at all. So, the pattern seems to be the arbitrary deletion of my contacts without giving me any notice at all in order to stop me from contacting attorneys about my criminal case for assistance. Again, I've done NOTHING wrong, but the FBOP continues to delete my contacts in violation of my constitutional rights and my rights of access to the courts.

If you put them back in they will either be approved or denied and you should be good. So long story short I deleted them per direction from AW

Here we go again! On May 31, 2024, an FBOP employee deleted 28 contacts from my account, including the deletion of 10 approved e-mail addresses and 6 approved telephone numbers. These contacts are attorneys such as Huma T. Yasin, Esquire; legal organizations such as the Defenders Association of Pennsylvania; family members, et alia. I was NEVER provided with any notice whatsoever. I have done NOTHING wrong. There's NO valid reason for the deletion of 28 people, 10 approved e-mail addresses, and 6 approved telephone numbers.

I asseverate that this FBOP employee deleted all of these contacts in order to (1) stop me from contacting lawyers and legal aid societies/organizations about the FCI McKean total book ban and magazine ban, as well as to (2) stop me from contacting lawyers and legal advocacy organizations about the police torturing me for a forced confession in my criminal case that left me with severe, permanent injuries: https://bio.link/anson_chi_help

This deletion of 28 contacts, 10 approved e-mail addresses, and 6 approved telephone numbers is a violation of my First Amendment right, Fifth Amendment right, Fourteenth Amendment right, etc.

* My Question: Can you please tell me who deleted my 28 contacts, 10 approved e-mail addresses, and 6 approved telephone numbers? (I aver that the party responsible is SIS or the FBOP Central Office CTU Department.)

The glue on the envelope edge is still dry.

On the envelope was marked 6 pages but I received nothing. I am sending you the

unsealed envelope so you can show it to the mailroom.

I will call your counselor tomorrow and I will try to write to the Warden.

Last time you sent me the letter was sealed. I suggest you put two stamps for 6 pages.

One stamp for 4 pages and the address you put on the envelope was right.

Pray to the Lord.

P.S. I talked to the mailroom, Mr. Sharp and got no answer.

Warden Ms. Newman,

I am Anson Chi's mother, and my son's registration number is 448-88-177. He is currently an inmate at McKean FCI.

My son wrote me two letters—one dated September 24, with a sealed envelope, and the other dated November 1, with an unsealed envelope. I have attached a copy of the unsealed letter for your reference. My son had written on the envelope that it contained 6 pages, but when I received it, the envelope was empty. I noticed that the glue on the envelope was still dry, which leads me to believe the envelope was never sealed by the mailroom.

My son informed me that he is not allowed to seal the envelope himself, and that the mailroom is responsible for sealing it after the letter has been inspected. This suggests that the mailroom may not have sealed my son's letter before sending it out.

As a mother, I am deeply concerned and disappointed by this situation. I was eagerly awaiting my son's letter, and finding the envelope empty was very distressing. On the morning of November 6, I contacted the mailroom, and Mr. Sharp told me that he was unaware of the issue.

I sincerely hope that this will not happen again, and I appreciate your attention to this matter.

I am lucky to get your letter only 5 days after because you only put one stamp for 7 pages. Can you listen to what I told you? You must put two stamps over 4 pages. Just follow what I said. This time I am lucky to get your mail but next time I might not have the luck again. The letter you dated November 2, 2024 on the envelope put 3 pages was sealed. This time 7 pages were not sealed. I believe if you put two stamps over 4 pages it should be safe.

The prison doesn't want you to read books, magazines or even email outside to get help, then, you just don't do anything. Follow their orders. I told you to be good, that means follow their orders even if it is not fair. Think about Our Lord Jesus, He is really treated unfairly, but He keeps quiet. I hope you just keep quiet until you come out.

Baba is happy when you say Happy Birthday to him and I am happy we made a sign to say happy birthday to you with my sister.

If you need money to pay for a phone call, I can send you money. Covid 19 is over, the Federal doesn't have money so you have to pay for everything. It is common sense. I feel sorry for the inmate Jerry. Maybe you pay for his phone call so he is safe. I know you got the \$200 dollars. If you want more money, just let me know. Don't forget to mail to my P.O. Try not to make any complaints because it doesn't help you to solve problems. Forget the 6 page letter and just send me again with 2 stamps.
